SHOW CAUSE NOTICE

Whereas, Nararanchal Senior Secondary School, Village Narar, District Kaithal was granted permanent recognition for Classes I to XII vide Order No. 25/1-2015 PS (4) dated 02.01.2017 by the District Education Officer, Kaithal and the Deputy Commissioner-cum-Chairman. Subsequently, the Director of School Education granted No Objection Certificate (NOC) vide Order No. 25/2-2018 PS (1) dated 26.02.2018 for granting affiliation with CBSE.

Whereas, the District Education Officer, Kaithal, vide Letter No. G1/26/2911-16 dated 18.05.2026, informed that an inspection committee was constituted on 27.04.2026 to conduct inspection of Nararanchal Play Way School run by S.K. Global Academy, Karnal Road, Kaithal. During the inspection, the following serious irregularities were observed:-

- 1. During the inspection, classes ranging from pre-nursery to 8th were found to be operational at the institute.*
- 2. Classes were found being conducted in the basement. Although the main entrance to the basement had been closed by the management, an access route via a staircase at the rear of the building was found open. Upon entering the basement, the committee found a computer lab and Grade 4 students engaged in their studies. It was also observed that there was no alternative provision for an emergency exit in the basement.*
- 3. According to the school management, approximately 250 students are enrolled at the institute; however, no registers or records pertaining to the students were presented to the committee. The school operator submitted a written statement acknowledging that the admission withdrawal register and the attendance register were incomplete.*
- 4. Students at the school were found to be using books published by Prachi Publications (a private publisher).*



-
5. *The school management stated that the application process for recognition of classes 1 through 8 is underway—with an inspection already conducted by the WCDPO—and that recognition for the play school is also in process.*
 6. *The school management further stated that students enrolled in other schools are invited to the academy for coaching. The students' uniforms bore the logos of both Nararanchal Senior Secondary School and SK Global Academy.*
 7. *During the inspection, it was observed that the building bore the name "Suresh Academy," while "Nararanchal Play School" was marked on the first floor. Buses parked on the premises displayed the inscription "SK Global Academy, Karnal Road, Kaithal."*

Whereas, Nararanchal Sr. Sec. School, Village Narar, Kaithal was granted permanent recognition on the condition that it shall abide by the rules, regulations, instructions of the appropriate authorities issued from time to time under the Haryana School Education Rules, 2003 and amended rules.

Whereas, conducting classes in the basement without adequate emergency exit arrangements, maintaining incomplete statutory records relating to admissions and attendance, operating classes without obtaining the requisite recognition, and using multiple names for the institution raise serious concerns regarding student safety, transparency, accountability, and regulatory compliance. Such acts of omission & commission amount to violations of the conditions of recognition and the statutory obligations cast upon the management of a recognised school.

Whereas, Rule 42(1) of the Haryana School Education Rules, 2003 provides for withdrawal of recognition for violation of Haryana School Education Rules, 2003. Rule 42 of Haryana School Education Rules, 2003 is reproduced here as under:-

Rule 42.(1) The appropriate authority may withdraw recognition/NOC of a school after giving a written notice, drawing the attention of acts of omission and commission contrary to the Acts/rules or



directions issued their under to the managing committee either directly or through Principal/ Head of the institution.

(2) The recognition/NOC of the school shall lapse if the school,-

(a) XXXX

(b) XXXX

(c) XXXX

(d) XXXX.

(e) Has not complied with one or more of the conditions of recognition, specified in these rules.

Therefore, a show cause notice is being issued to the school management of the said school as to why the recognition/NOC granted to the school may not be withdrawn under Haryana School Education Rules, 2003.

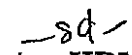
