Whereas Tagore Senior Secondary School, Majra Khurd, Distt. Mahendergarh was granted permanent recognition for classes 1 to 12th vide order 25.06.2008 under the provisions of Haryana School Education Rules, 2003.

Whereas, a grievance bearing Complaint No. GOVHY/E/2025/0011640 was lodged on the CP GRAM Portal by Ms. Pari Rao, Village Rewasa, District Mahendergarh, alleging that Tagore Senior Secondary School, Majra Khurd, District Mahendergarh, affiliated with the Central Board of Secondary Education (CBSE), has been conducting classes in a newly constructed school building for the last four years without obtaining prior approval from the competent authority and without permission from CBSE for shifting its school campus, as required under the applicable rules and affiliation bye-laws.

The matter was inquired into by the District Education Officer, Narnaul and vide its report dated 06.11.2025, it has been reported that the school has started its functioning to the new building without obtaining prior permission of the competent authority and has recommended disciplinary action against the school.

Thus, by doing so, the school has violated the provision of Rule 42 of Haryana School Education Rules 2003, which is reproduced here as under:-

"Rule 42.(1) The appropriate authority may withdraw recognition/NOC of a school after giving a written notice, drawing the attention of acts of omission and commission contrary to the Acts/rules or directions issued their under to the managing committee either directly or through Principal/ Head of the institution.

(2) The recognition/NOC of the school shall lapse if the school,-

(a) XXXX

(b) XXXX

[Handwritten signature]

(e) XXXX

(d) XXXX.

(e) *Has not complied with one or more of the conditions of recognition, specified in these rules."*

On the basis of the report of District Education Officer, Narnaul it is clear that the school is being run by the management in clear violation of Rule 42 (1) the Haryana School Education Rules, 2003 which provides for the withdrawal/suspension of recognition/NOC of the school if any provision of the rules is violated by the management.

Therefore, in the exercise of power conferred upon me under Rule 42(1) of the Haryana School Education Rules, 2003, a show cause notice is being issued to the school management as to why the recognition/NOC granted to their school may not be withdrawn/ suspended.

The reply, if any, the management wants to submit, should reach in the Department within a period of 15 days, failing which, it will be presumed that the Management has nothing to say in this regard and the appropriate order shall be passed in accordance with Rules.
