SHOW CAUSE NOTICE

Order No. 7/51-2024 PS (1)

Dated, Panchkula, the 21-08-2024

Whereas, S.D. Senior Secondary School, Narwana, Jind was granted permanent recognition for classes up to 1st to 10th vide order No. 1559-23/35-75 V(5) dated 10.03.1976 and for 11th class vide order No. 23/12-81 V(5) dated 08.01.1982.

Whereas, Sh. Suresh Kumar Mittal, PGT Political Science was appointed in a Govt. Aided School on 18.11.1985 in S.D. Senior Secondary School, Narwana, Jind and retired from service on 31.05.2021 from Govt. Senior Secondary School, Frain Kalan, Jind.

Whereas, he filed a CWP No. 29679 of 2022 titled as Suresh Kumar Mittal Vs. State of Haryana and others praying herein for directing the respondents No. 4 to release the part of Gratuity, GPF, GIS and pensionary benefits of the petitioner alongwith interest @24% per annum from the date of retirement i.e. 31.05.2021. The petitioner further prayed for directing the respondent School Management to release the retiral benefit which were withheld by them without any sufficient cause.

Whereas, the retiral benefits of the petitioner were released by the answering respondents up to the extent of 75% in accordance with rules 54 & 55 of Haryana School Education Rules, 2003. However, the remaining 25% being the management share of retiral benefits, has not been released by the concerned School Management to the petitioner till date whereas the same is to be released by the Management.

Whereas, several letters dated 09.09.2022, 10.10.2022, 14.11.2022, 09.12.2022, 09.01.2023, 10.02.2023, 23.02.2023, 15.03.2024, 18.03.2024 and 21.03.2024, were issued by the District Education Officer, Jind to the concerned



School Management for payment of 25% management share of gratuity to the petitioner but till date no payment has been made by the School Management.

Whereas, Rule 6(1) of Haryana Voluntary State Education Rules, 2017 provides that all liability prior to date of appointment of the employees in Government services is to be discharged by the management only.

Rule 6(1) of Haryana Voluntary State Education Rules, 2017 is reproduced here as under:-

“(1) The management shall be bound to discharge all liabilities in respect of employees appointed to the service for the period prior to date of appointment under these rules. The mere appointment of employees in the service shall not absolve the management of the responsibilities to clear the pending dues. The employees taken over shall have every right to claim their dues from the previous in respect of the previous services rendered by them.”

Whereas Rule 42(1) of the Haryana School Education Rules, 2003 provides for withdrawal of recognition for violation of Haryana School Education Rules, 2003, which is reproduced here as under:-

“Rule 42(1) The appropriate authority may withdraw recognition/NOC of a School after giving a written notice, drawing the attention of Acts of omission and commission contrary to the Acts/Rules or directions issued thereunder to the managing committee either directly or through Principal/Head of the institution.

(2) the recognition/NOC of the school shall lapse if the school;

a) XXXXX

b) XXXXX

c) XXXXX

d) XXXXX

e) *Has not complied with one or more of the conditions of recognition, specified in these rules.*

Whereas, the School Management has failed to comply with the provisions of the Haryana School Education Rules, 2003 particularly by not releasing its 25% share of retiral benefits payable to the petitioner despite repeated directions issued by the District Education Officer, Jind. Therefore, a show cause notice is being issued to the School Management of the said School for explaining as to why the recognition granted to the School may not be withdrawn by invoking the provision of Rule 42 of the Haryana School Education Rules, 2003.

The reply, if any, the Management of said school wants to submit, should be sent to this Department within a period of 15 days, failing which, it will be presumed that the Management of the school has nothing to say in this regard and the appropriate order shall be passed in accordance with the relevant Rules.
