SHOW CAUSE NOTICE

Memo No. 38/45-2026 PS (2)

Dated, Panchkula 01-09-2026

Whereas Gian Sagar Public Senior Secondary School, Rori, District Sirsa was granted permanent recognition for classes 1 to 12th vide order No. 12/8-2011PS(1) dated 04.01.2012 and NOC for affiliation with CBSE by the Directorate of School Education, Haryana vide order dated 04.04.2012 under the provisions of Haryana School Education Rules, 2003.

Whereas, a complaint bearing CM Window No. 129051 and 046821 was submitted by Shri Tilak Rai, Village Rori, District Sirsa, alleging that Gian Sagar Public Senior Secondary School, Rori, District Sirsa, affiliated with the Central Board of Secondary Education (CBSE), does not possess NOCs from various Departments as required under the applicable rules and affiliation by-laws.

The matter was inquired into by the Block Education Officer, Baragudha, Sirsa and vide its report dated 12.06.2025, it has been reported that during the course of inspection, the Principal of Gian Sagar Public Senior Secondary School, Rori, Block Baragudha, District Sirsa, initially refused to produce the relevant school records before the Committee. Subsequently, when the Block Level Committee again visited the school premises on 04.06.2025 for verification/inspection of the records, the records were produced and upon examination of the records and physical verification of the school premises, the following deficiencies were found:-

1. The NOC issued by the Public Health Department vide Letter No. 149 dated 14.07.2023 was valid for a period of one year only. The said NOC has not been renewed by the school after expiry of its validity.
2. The Fire Safety NOC issued vide Department Letter No. F5/2023-24 dated 07.07.2023 was valid for a period of three



years wherein orders were issued for proper maintenance and keeping the fire-fighting equipments in working condition from time to time. However, during physical inspection, the Fire Extinguishers installed in the school were found not duly refilled/operational, and no CO₂ Fire Extinguisher was found available in the school. It was also observed that the fire hose was also not in working/usable condition.

3. The School Structure Safety NOC issued by B.B. Gera vide Letter No. BBG/06/2023 dated 25.06.2023 was valid for a period of one year. The said NOC was not found renewed after expiry of its validity. Renewal of the requisite structural safety certification/NOC from the competent PWD (B&R) Department is required.
4. The Hygiene and Sanitation Certificate issued vide Department Letter No. E/IV/23/368 dated 27.06.2023 was valid for a period of one year. The same was not found renewed by the competent authority/Civil Surgeon after expiry of its validity.
5. The Principal of Gian Sagar Public Senior Secondary School, Rori, has furnished a statement on the school letterhead that the school vans are not operated by the school and that such vehicles are being operated by the students' parents/guardians. The said position requires verification regarding the authorization and compliance with the applicable transport/safety requirements. The matter may, therefore, require verification by the competent Regional Transport Authority (RTO).

Thus, by doing so, the school has violated the provision of Rule 43 of Haryana School Education Rules 2003, which is reproduced here as under:-

"43(1) The appropriate authority may withdraw/suspend the recognition/N.O.C of a school after giving reasonable opportunity



against the proposed action to be taken against the school in the following circumstances:-

- (a) If, a school ceases to fulfil any requirement of the Act or any of the conditions of these rules;
- (b) X xxxxxxxxxxxx
- (c) X xxxxxxxxxxxx
- (d) X xxxxxxxxxxxx

On the basis of the report of Block Education Officer, Baragudha, Sirsa it is clear that the school is being run by the management in clear violation of Rule 43 (1) the Haryana School Education Rules, 2003 which provides for the withdrawal/suspension of recognition/NOC of the school if any provision of the rules is violated by the management.

Therefore, in the exercise of power conferred upon me under Rule 43(1) of the Haryana School Education Rules, 2003, a show cause notice is being issued to the school management as to why the recognition/NOC granted to their school may not be withdrawn.

The reply, if any, the management wants to submit, should reach in the Department within a period of 15 days, failing which, it will be presumed that the Management has nothing to say in this regard and the appropriate order shall be passed in accordance with Rules.
