Whereas Baba Chotu Nath Senior Secondary School, Sisana, Tehsil Kharkhoda, District Sonipat was granted temporary recognition for classes 1 to V vide letter No. E-1-97/2272-75 dated 04.09.1997 issued by the Sub Divisional Education Officer, Sonipat and permanent recognition for classes 6th to 8th was granted by the District Education Officer, Sonipat vide letter No. E-1-2000/860-62 dated 04.09.2000. Further, permanent recognition for classes 9th to 12th was granted vide order No. G-1-2015/2169-74 dated 21.01.2015 by the Committee comprising the Deputy Commissioner, Sonipat as Chairman and the District Education Officer, Sonipat as Member Secretary under the provisions of Haryana School Education Rules, 2003.

Whereas, a complaint was received from Smt. Sunita W/o Sh. Gajraj, Resident of Village Sisana, District Sonipat through CM Window vide Complaint No. CMOFF/N/2026/034193, alleging therein various irregularities and violations by Baba Chotu Nath Senior Secondary School, Sisana, including non-compliance with the provisions of the Right of Children to Free and Compulsory Education Act, 2009 and the Haryana School Education Rules, 2003. Various allegations were levelled against Baba Chotu Nath Senior Secondary School, Sisana such as deficiency of land area, non-availability of playground, absence of mandatory safety certificates, lack of access for fire brigade vehicles and irregularities regarding the lease deed.

Whereas, in pursuance of the aforesaid complaint, an inspection of the school was conducted by the Block Education Officer, Kharkhoda, and as per the inspection report dated 05.05.2026, the following deficiencies and violations were found:

- The available land area of the school was found to be only 1210 square metres against the prescribed minimum requirement of 2500 square metres

which is in violation of Rule 30.b(i) of the Haryana School Education Rules, 2003 as amended from time to time.

ii. Essential infrastructure facilities, namely Library and Computer Room, were not available in violation of Rule 30(b)(ii-F)

iii. Only 10 classrooms were available against the prescribed requirement of 12 classrooms, which is the violation of Rule 30(b)(ii)(a)

iv. Ramp facility for persons with disabilities was not available and the width of the staircase was found below the prescribed norms, in violation of Rule 30(b)(ii)(h).

v. The following mandatory certificates/documents were not available in the school record:

a. Land Ownership Certificate under Rule 31.1

b. Building Safety Certificate under Rule 31.1

c. Fire Safety Certificate under Rule 31.1

d. Health/Hygiene Certificate under Rule 31.1

vi. No record regarding the prescribed pledge money, as required under Rule 30.2 was produced by the school authorities.

On the basis of enquiry report, the District Education Officer, Sonapat has recommended that the recognition granted to the school may be cancelled.

Thus, by doing so, the school has violated the provision of Rule 43 of Haryana School Education Rules 2003, which is reproduced here as under:-

"43(1) The appropriate authority may withdraw/suspend the recognition/N.O.C of a school after giving reasonable opportunity against the proposed action to be taken against the school in the following circumstances:-

- (a) If, a school ceases to fulfil any requirement of the Act or any of the conditions of these rules;**
- (b) X xxxxxxxxxxxx**
- (c) X xxxxxxxxxxxx**
- (d) X xxxxxxxxxxxx**

On the basis of the report of Block Education Officer, Kharkhoda it is clear that the school is being run by the management in clear violation



of Rule 43 (1) the Haryana School Education Rules, 2003 which provides for the withdrawal/suspension of recognition/NOC of the school if any provision of the rules is violated by the management.

Therefore, in the exercise of power conferred upon me under Rule 43(1) of the Haryana School Education Rules, 2003, a show cause notice is being issued to the school management as to why the recognition/NOC granted to their school may not be withdrawn.

The reply, if any, the management wants to submit, should reach in the Department within a period of 15 days, failing which, it will be presumed that the Management has nothing to say in this regard and the appropriate order shall be passed in accordance with Rules.
