Whereas, Sh. Himmat Singh had filed CWP No. 18299 of 2026 titled as Himmat Singh Vs State of Haryana and others before Hon'ble Punjab and Haryana High Court praying therein for issuance of appropriate directions to the respondents to grant him the benefit of notional promotion to the post of TGT w.e.f. 12.12.2010, along with all consequential benefits, and thereafter to grant him the benefit of promotion to the post of PGT Sociology w.e.f. 30.05.2016, for the purpose of fixation of seniority and other consequential service benefits, at par with his junior, namely Sh. Shamsheer Singh, who had allegedly been promoted to the corresponding posts and granted consequential benefits vide orders dated 12.12.2010 and 08.07.2019. The petitioner had further prayed for issuance of appropriate directions to respondent No. 1 to decide his legal notice dated 21.04.2026 within a stipulated time-bound manner.

The above-mentioned writ petition came up for adjudication before the Hon'ble High Court on 14.07.2026 and was disposed of vide order dated 14.07.2026 with a direction to hear and decide the legal notice dated 21.04.2026 (Annexure P-12) of the petitioner and pass a speaking order within a period of three months from the date of receiving a certified copy of the order. The operative part of the said order is reproduced hereunder:—

“.....2. Learned counsel for the petitioner, at the outset, raises a preliminary grievance that several employees similarly situated to the petitioner, who were appointed much after him, were granted promotion vide order dated 12.12.2010 (Annexure P-3) and were further promoted as PGTs vide order dated 30.05.2016 (Annexure P-4). It is further submitted that even the petitioner's junior including Shamsheer Singh, who was

appointed as a TGT on 01.10.2003, have been extended the said benefit. Learned counsel further submits that the petitioner's case for grant of notional promotion along with consequential seniority benefits has already been forwarded by the competent authority vide communication dated 02.04.2026 (Annexure P-11), but no final decision has been taken thereon till date. At this stage, learned counsel submits that the petitioner would be satisfied if a direction is issued to the respondents/competent authority to consider and decide the legal notice dated 21.04.2026 (Annexure P-12) by passing a reasoned and speaking order, in accordance with law, within a stipulated period.

3. On advance notice, learned State counsel submits that he has objection in the event a direction is issued respondents/competent authority to consider and decide the legal notice dated 21.04.2026 (Annexure P-12) by passing a reasoned and speaking order within a stipulated period.

4. In view of the limited prayer made by counsel for the petitioner without commenting upon the merits of the case, the present petition is disposed of and the respondents/competent authority is directed to hear and decide legal notice dated 21.04.2026 (Annexure P-12) by passing a speaking order in a time bound manner within a period of three months from the date of receiving a certified copy of this order. Further the decision taken thereof shall be conveyed to the petitioner.

5. Needless to say, if the petitioner is found entitled to the relief sought, the same be granted forthwith by respondent/competent authority.

6. Pending miscellaneous application(s), if any, shall also stands disposed of."

In compliance with the order dated 14.07.2026 passed by the Hon'ble Court, the representation/legal notice dated 21.04.2026 submitted by Sh. Himmat Singh, PGT Sociology, GMSSSS Kanina, District Mahendergarh, has been duly examined in light of the relevant service record and the applicable statutory provisions. The petitioner was appointed as JBT vide appointment order dated 06.10.2000. It has been



stated that the matter relating to the promotion of teachers appointed/selected in the year 2000 remained sub judice for a considerable period. The petitioner has contended that owing to the pendency of litigation concerning the JBT recruitment, his case for promotion to the next promotional post could not be considered at the relevant time. Accordingly, he has claimed entitlement to notional promotion to the post of TGT/SS Master w.e.f. 12.12.2010 and, thereafter, to the post of PGT Sociology w.e.f. 30.05.2016, on the ground that his junior, namely Sh. Shamsheer Singh, was promoted to the corresponding post and was granted consequential benefits. He has further sought fixation of his seniority and grant of all consequential benefits with effect from the respective dates claimed by him.

Whereas, the representation dated 02.04.2026 submitted by the petitioner and forwarded by the District Education Officer, Narnaul, has been examined in the light of the petitioner's service particulars, relevant service record and the applicable provisions of the Haryana State Education School Cadre (Group-B) Service Rules, 2012, as placed on record by the Department on 03.07.2026. It is observed from the record that the petitioner was appointed as JBT on 06.10.2000 and was never promoted to the post of TGT/SS Master, whereas promotion to the post of PGT is made from the prescribed feeder post of TGT. As per the available record, Sh. Shamsheer Singh was appointed as JBT on 01.10.2003 and was subsequently promoted from the post of JBT to the post of SS Master vide Order No: 2/42-2010 HRM-I(2) dated 12.12.2010. The petitioner, however, did not acquire promotion to the feeder/promotional post of TGT/SS Master at the relevant point of time and was not granted promotion to the said post w.e.f. 12.12.2010. Subsequently, the petitioner was appointed as PGT Sociology on direct recruitment basis and joined the post of PGT on



28.12.2018. The promotion granted to Sh. Shamsher Singh and other employees vide order dated 12.12.2010 cannot, by itself, be construed as conferring an indefeasible right upon the petitioner to claim retrospective or notional promotion, unless he fulfils the statutory conditions prescribed for such promotion. The petitioner's subsequent appointment as PGT Sociology being a direct appointment, the same cannot be treated as a retrospective promotion from the post of TGT/SS Master in the absence of any specific order or statutory provision to that effect. The applicable provisions of the Haryana State Education School Cadre (Group-B) Service Rules, 2012 do not provide for automatic grant of retrospective/notional promotion merely on the ground that an employee allegedly junior to the petitioner was promoted earlier. Consequently, in the absence of any legally sustainable order granting promotion to the petitioner to the feeder post of TGT/SS Master w.e.f. 12.12.2010, his consequential claim for further notional promotion to the post of PGT Sociology w.e.f. 30.05.2016 cannot be accepted. Likewise, the claim for retrospective fixation of seniority and consequential financial and service benefits is dependent upon the petitioner's entitlement to the underlying promotion. Since, the foundational claim for notional promotion to the feeder post is not established under the applicable statutory rules, the consequential claims arising therefrom are also not admissible.

In view of the above, the representation/legal notice dated 21.04.2026 submitted by Sh. Himmat Singh has been duly considered in compliance with the order dated 14.07.2026. Upon examination of the relevant service record and the applicable statutory provisions, it is found that the petitioner has not established any statutory or enforceable entitlement to retrospective/notional promotion to the post of TGT/SS Master with effect from 12.12.2010. Consequently, the claim of the



petitioner for further notional promotion to the post of PGT Sociology with effect from 30.05.2016, fixation of seniority with effect from the date of promotion of Sh. Shamsheer Singh, and consequential benefits also cannot be acceded to. Accordingly, the claim of Sh. Himmat Singh, demanded through legal notice is hereby rejected for the reasons stated above.
