Whereas, CWP No. 14105 of 2026 titled as Shri Kannav Education Society Vs State of Haryana & Others has been filed by the petitioner with the prayer to set aside approval granted by Official respondents to the respondent No. 7 i.e. Wisdom International School, village Badoni, Tehsil Pehowa, District Kurukshetra to admit the students without getting recognition & affiliation from the respective board. Further, a writ in the nature of mandamus to restrain respondent No. 7 from admitting students from academic session 2026-27.

Whereas, in pursuance of the aforesaid civil writ petition, DEO Kurukshetra was directed to verify the facts w.r.t Wisdom International School, Pehowa, Kurukshetra and submit report. District Education Officer, Kurukshetra vide its report dated 31.08.2026 has informed that an Enquiry Committee was constituted under Block Education Officer, Pehowa, Kurukshetra to enquire into the matter and the committee has concluded as under:-



"The school had issued admission prospectus dated 08.03.2026, wherein admissions for the academic session 2026-2027 were invited/advertised. Thus, the admission process was initiated by the school before the grant of recognition. Further, the school had granted provisional admission to students bearing Nos. 80, 81, 161, 194, 196, 285, 286, 314 and 315 before the grant of recognition dated 20.05.2026."

That rule 30 (1)(a)(iii) of the Haryana School Education Rules, 2003 provides that *"No admission beyond class-III shall be made by any school before the sanction of its recognition or in its anticipation."*

Thus, by doing so, the school has violated the provision of Rule 42 of Haryana School Education Rules 2003, which is reproduced here as under:-

"Rule 42.(1) The appropriate authority may withdraw recognition/NOC of a school after giving a written notice, drawing the attention of acts of omission and commission contrary to the Acts/rules or directions issued their under to the managing committee either directly or through Principal/ Head of the institution.

(2) The recognition/NOC of the school shall lapse if the school,-

(a) XXXXX

(b) XXXXX

(c) XXXXX

(d) XXXXX.

(e) Has not complied with one or more of the conditions of recognition, specified in these rules."

On the basis of the report of District Education Officer, Kurukshetra, it is clear that the school is being run by the management in clear violation of Rule 42 (1) the Haryana School Education Rules, 2003 which provides for the withdrawal/suspension of recognition/NOC of the school if any provision of the rules is violated by the management.

Therefore, in the exercise of powers conferred upon me under Rule 42(1) of the Haryana School Education Rules, 2003, a show cause notice is being issued to the school management as to why the



recognition/NOC granted to their school may not be withdrawn/suspended.

The reply, if any, the management wants to submit, should reach in the Department within a period of 15 days, failing which, it will be presumed that the Management has nothing to say in this regard and the appropriate order shall be passed in accordance with Rules.
