Whereas Golden India Public School, Surya Vihar, Part-3, Sector-91, Faridabad was granted recognition by Board of School Education Haryana, Bhiwani.

Whereas, a grievance bearing Complaint No. CMOFF/N/2025/040921 was lodged on the CM Window Portal by Shri. Dheeraj Pal, village Sotai, Faridabad alleging that Golden India Public School, Surya Vihar, Part-3, Sector-91, Faridabad, does not possess the necessary documents as required under the applicable rules and affiliation bye-laws.

Whereas, in pursuance of the aforesaid complaint, an inspection of the school was conducted by the Block Education Officer, Faridabad, and as per the inspection report dated 11.11.2025, the following deficiencies and violations were found:

1. The school did not provide the Land Registration documents.
2. No revenue documents were provided.
3. No permission letter was provided.
4. The school is affiliated with Board of School Education Haryana, Bhiwani and not CBSE.
5. The school does not possess playground.
6. Hygiene Certificate was not available.
7. Visitor Register was not available.

On the basis of enquiry report, the District Education Officer, Faridabad has recommended that departmental action may be initiated against the school.

Thus, by doing so, the school has violated the provision of Rule 42 of Haryana School Education Rules 2003, which is reproduced here as under:-

"Rule 42.(1) The appropriate authority may withdraw recognition/NOC of a school after giving a written notice, drawing the attention of acts of omission and commission contrary to the Acts/rules or directions issued their under to the managing committee either directly or through Principal/ Head of the institution.

(2) The recognition/NOC of the school shall lapse if the school,-

(a) XXXX

(b) XXXX

(e) XXXX

(d) XXXX.

(e) Has not complied with one or more of the conditions of recognition, specified in these rules."

On the basis of the report of Block Education Officer, Faridabad it is clear that the school is being run by the management in clear violation of Rule 42 (1) the Haryana School Education Rules, 2003 which provides for the withdrawal/suspension of recognition/NOC of the school if any provision of the rules is violated by the management.

Therefore, in the exercise of power conferred upon me under Rule 42(1) of the Haryana School Education Rules, 2003, a show cause notice is being issued to the school management to explain its position as to why the recognition/NOC granted to their school may not be withdrawn/ suspended.

The reply, if any, the management wants to submit, should reach in the Department within a period of 15 days, failing which, it will be presumed that the Management has nothing to say in this regard and the appropriate order shall be passed in accordance with Rules.

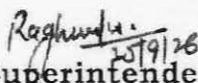

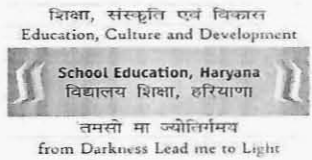

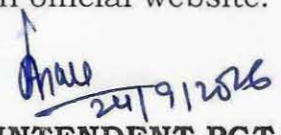
