Whereas, Smt. Bhateri Bai has filed CWP No. 19036 of 2026 titled as Bhateri Bai v/s State of Haryana and others before the Hon'ble Punjab and Haryana High Court praying therein for issuance of a writ in the nature of mandamus directing the respondents to consider and promote the petitioner to the post of PGT English/Lecturer English as she possesses the requisite essential qualification with more than 50% marks from recognized University and experience. Further, for directing the respondents to grant relaxation to the petitioner from the requirement of two years' teaching experience as TGT English under Rule 17 of the Haryana State Education School Cadre (Group-B) Service Rules, 2012 particularly when similar relaxations/exemptions were earlier granted by the Government in respect of HTET/STET and B.Ed. qualifications vide notifications (Annexures P-6 to P-8).

The above mentioned writ petition came up for hearing on 01.07.2026, on that day, the Hon'ble Court disposed of the same with the following orders as under: -

".....Learned counsel for the petitioner further submits that she would be satisfied if the representation (Annexure P-9) of the petitioner is decided by respondent No.2 by passing a speaking order in a time bound manner.

4. Learned State counsel, appearing on advanced notice, submits that he has no objection in case a direction is issued to respondent No.2 for time bound consideration and decision of the representation of the petitioner by passing a speaking order.

5. Therefore, in view of the limited prayer made by learned counsel for the petitioner, respondent No.2 is directed to consider the representation (Annexure P-9) of the petitioner and

ju

pass a speaking order, after affording her an opportunity to be heard, within a period of 03 months from the date of receiving a certified copy of this order. Further, the decision taken thereof shall be conveyed to the petitioner. Needless to say, if the petitioner is found entitled to the relief sought, the same shall be granted forthwith by respondent No.2.

6. Disposed of, accordingly.”

In compliance with the above said order dated 01.07.2026 passed by the Hon'ble Court, representation/legal notice dated 13.02.2026 of the petitioner has been duly examined in light of relevant rules. The petitioner is seeking promotion to the post of PGT (English) as she possesses the requisite essential qualification with more than 50% marks from recognized University and experience.

As per the MIS report, the petitioner was appointed as JBT on 07.11.1995 and joined her duties on 25.11.1995. Thereafter, the petitioner was promoted from the post of JBT to the post of TGT (Sanskrit) vide order dated 05.09.2008 and joined her duties as TGT (Sanskrit) on 08.09.2008. The petitioner passed M.A. (English) from Maharshi Dayanand University (MDU) in the year 2010 with 64.4% marks and also possesses the qualification of B.Ed. from MDU, which she passed in the year 1989. However, as per the provisions contained under the Haryana State Education School Cadre (Group-B) Service Rules, 2012, the prescribed qualifications and eligibility conditions for promotion to the post of PGT (English) are as under:-

By promotion:

- i) M.A. English with atleast 50% marks and B.Ed from recognized university;**
- ii) 2 years teaching experience as TGT English Teacher; or Two Years' experience of teaching English in case of TGT Social Studies having English as an Elective Subject in Graduation.**

As per the aforesaid provisions, it is observed that the petitioner is presently working as TGT (Sanskrit) and does not possess the prescribed

two years' teaching experience as TGT (English). Further, the petitioner also does not fall within the alternative category of TGT (Social Studies) having English as an elective subject at the Graduation level. Thus, the petitioner does not fulfil the prescribed eligibility conditions for promotion to the post of PGT (English) under the Haryana State Education School Cadre (Group-B) Service Rules, 2012.

Whereas, Rule-17 of the Haryana State Education School Cadre (Group-B) Service Rules, 2012 provides for relaxation in the provisions of these rules in respect of any class or category of persons. The relevant provisions of Rule-17 are reproduced as under:-

Rule-17. Where, the Government is of the opinion that it is necessary or expedient to power of do so, it may be order, for reason to be recorded in writing, relax any of the relaxation provisions of these rules with respect to any class or category of persons.

Whereas, the petitioner has sought relaxation of the prescribed experience condition by invoking Rule-17 of the aforesaid Service Rules and has relied upon certain earlier instances/orders/notifications wherein relaxation was granted in respect of qualifications such as HTET/STET and B.Ed. However, the said instances pertain to relaxation of specific qualification requirements and cannot, merely on that basis, be treated as precedent for relaxation of the prescribed teaching experience required for promotion to the post of PGT (English).

That, in compliance with the order dated 01.07.2026 passed by the Hon'ble Court, a personal hearing was duly afforded to the petitioner by the undersigned on 27.08.2026. After considering the submissions made by the petitioner and examining the facts of the case in light of the applicable Service Rules and instructions, the claim of the petitioner was not found admissible and, accordingly, was declined.

In light of the applicable rules and the position explained hereinabove, the petitioner of Smt. Bhateri Bai does not fulfil the prescribed eligibility conditions for promotion to the post of PGT (English) under the Haryana State Education School Cadre (Group-B) Service Rules, 2012. Hence, she does not satisfy the prescribed criteria governing such promotion and lacks the requisite merit for consideration. Accordingly, the claim of Smt. Bhateri Bai is hereby rejected for the reasons stated above, being devoid of merit.

Whereas, Smt. Suman Devi had filed CWP No. 12059 of 2026 titled as Suman Devi v/s State of Haryana and others praying therein for seeking issuance of a writ in the nature of mandamus directing respondent No. 2 to promote the petitioner to the post of PGT Chemistry w.e.f. 01.04.2021, i.e. the date on which persons junior to her were promoted, whereas the petitioner was ignored on account of charge-sheet dated 08.09.2015. The said charge-sheet has been dropped vide letter dated 29.10.2024.

The above mentioned writ petition came up for adjudication on 20.07.2026, on that day the Hon'ble High Court disposed of the same with the following orders: -

".....Learned State counsel, appearing on advanced notice, submits that he has no objection in case a direction is issued to respondent No.2 for time bound consideration and decision of the representation-cum-legal notice (Annexure P-16) of the petitioner by passing a speaking order.

5. Therefore, in view of the limited prayer made by learned counsel for the petitioner, respondent No.2 is directed to consider the representation cum-legal notice (Annexure P-16) of the petitioner in light of the judgment rendered by this Court in Gurvinder Singh's case (supra) and pass a speaking order, after affording her an opportunity to be heard, within a period of 03 months from the date of receiving a certified copy of this order. Further, the decision taken thereof shall be conveyed to the petitioner. Needless to say, if the petitioner is found entitled to the relief sought, the same shall be granted forthwith by respondent No.2."

In compliance with the above said order dated 20.07.2026 passed by the Hon'ble Court, legal notice dated 12.02.2026 of the petitioner has been duly examined. The petitioner is seeking promotion to the post of PGT



(Chemistry) with effect from 01.04.2021 i.e. from the date, their juniors were promoted to the said post.

Whereas, the petitioner, namely Smt. Suman Devi was selected pursuant to Advertisement No. 1/2009 whereby 9647 posts of JBT Teachers were advertised. The selection process pursuant thereto was challenged vide CWP No. 3 of 2011 titled as Parveen Kumari & Others vs. State of Haryana & Others, which was dismissed by the Hon'ble High Court on 03.08.2015. Consequently, departmental proceedings were initiated against the petitioner on allegations of impersonation in the HTET examination on the basis of an inconclusive FSL report relating to signatures. Accordingly, the petitioner was charge-sheeted under Rule-7 vide letter No. 16/11-2011 ET-II(4) dated 02.09.2015 issued by the Elementary Education Department, Haryana, and further vide letter No. E-IV-15/820-23 dated 08.09.2015 issued by the District Elementary Education Officer, Bhiwani.

Whereas, in compliance with the directions issued by the Hon'ble High Court vide order dated 27.09.2022 passed in CWP No. 5720 of 2022 titled Devi Chand & Others vs. State of Haryana & Others, the charge-sheet issued against the petitioner was withdrawn vide letter No. 16/24-2023 PRT (Art) dated 14.10.2024 issued by the Director of Elementary Education, Haryana, Panchkula, and letter No. E-4-24/1651-53 dated 29.10.2024 issued by the DEEO, Bhiwani. Subsequently, the petitioner was promoted by the Elementary Education Department, Haryana to the post of TGT Science w.e.f. 14.10.2024 vide order No. 5/18-2024 TGT Pro. (1) dated 03.12.2024/21.12.2024.

Thereafter, she was granted antedated promotion to the post of TGT Science w.e.f. 22.03.2016 instead of 28.06.2024, along with the benefit of notional pay fixation and seniority, though without monetary benefits. The



petitioner joined as TGT Science on 24.02.2025 and her seniority was subsequently re-fixed at Seniority No. 11744-A by the Elementary Education Department, Haryana as per the provisional seniority list as on 01.07.2020 vide order dated 02.02.2026.

Whereas, the requisite qualification for promotion to the post of PGT Chemistry, as prescribed under the Haryana State Education School Cadre (Group-B) Service Rules, 2012, is as under:-

By promotion:

- (i) M.Sc. Chemistry or Bio Chemistry with atleast 50% marks and B.Ed from recognized university; AND**
- (ii) 2 years teaching experience as TGT Science; AND**
- (iii) Certificate of having qualified Haryana Teacher Eligibility Test (HTET)/School Teachers Eligibility Test (STET).**

Whereas, Sh. Gurvinder Singh and Sh. Subhash Chand had filed CWP No. 16150 of 2016, titled *Gurvinder Singh and another v. State of Haryana*, seeking directions for their promotion to the post of PGT (Economics) with effect from 26.04.2016. Both petitioners were promoted to the post of TGT S.S. Master with effect from 12.12.2010 vide orders dated 17.04.2012 and 30.07.2012 and they joined as TGT S.S. Master on 17.04.2012 and 01.08.2012, respectively. Subsequently, they were promoted to the post of PGT (Economics) vide order dated 24.04.2017. Aggrieved by the said order, they approached the Hon'ble High Court. It is pertinent to mention here that the Department had promoted 2090 TGTs vide order dated 26.04.2016, for which 01.01.2014 was prescribed as the cut-off date for determining eligibility. In compliance with the order dated 16.05.2018 passed by the Hon'ble High Court in CWP No. 16150 of 2016, Sh. Gurvinder Singh and Sh. Subhash Chand were subsequently granted promotion to the post of PGT (Economics) with effect from 26.04.2016 vide orders dated 11.09.2018 and 03.10.2018, respectively.

However, the facts and circumstances of the present case are materially different from those involved in CWP No. 16150 of 2016. In the present case, the petitioner is claiming promotion to the post of PGT (Chemistry) with effect from 01.04.2021. Although the petitioner was subsequently granted antedated promotion to the post of TGT Science with effect from 22.03.2016 vide order dated 19.06.2025, along with the benefit of notional pay fixation and seniority, she actually joined the post of TGT Science only on 24.02.2025. Under the Haryana State Education School Cadre (Group-B) Service Rules, 2012, promotion to the post of PGT (Chemistry) requires, inter alia, two years' teaching experience as TGT Science. Therefore, the petitioner did not possess the requisite two years' teaching experience as TGT Science on 01.04.2021, the date from which she is seeking promotion.

Accordingly, the ratio of the judgment passed in CWP No. 16150 of 2016 is not directly applicable to the present case. In the said case, the petitioners had already acquired the requisite teaching experience by 26.04.2016, but their cases were not considered due to the prescribed cut-off date. In contrast, in the present case, the petitioner had not acquired the statutory requirement of two years' teaching experience as TGT Science as on 01.04.2021, the date from which she is claiming promotion. The subsequent grant of antedated promotion as TGT Science with notional benefits cannot, by itself, alter the factual position regarding her actual teaching experience on the claimed date, particularly when the statutory eligibility conditions for promotion to the post of PGT (Chemistry) are required to be satisfied.

It is further pertinent to mention that any decision in favour of the petitioner may have wider ramifications, as there may be several similarly situated cases wherein employees could claim identical relief on the basis



of antedated promotion and notional seniority. Such a decision may, therefore, result in further claims and litigation. Since the matter involves interpretation and application of the statutory service rules, particularly with regard to the requirement of two years' teaching experience as TGT Science.

In compliance with the order dated 20.07.2026 passed by the Hon'ble Court, a personal hearing was duly afforded to the petitioner by the undersigned on 27.08.2026. After considering the submissions made by the petitioner and examining the facts of the case in light of the applicable service rules and instructions, the claim of the petitioner was not found admissible and, accordingly, was declined.

In light of the applicable rules and the position explained hereinabove, the claim of Smt. Suman Devi for promotion to the post of PGT Chemistry with retrospective effect from the date on which their juniors were promoted is not tenable. The claim does not satisfy the prescribed criteria governing such promotion and lacks the requisite merit for consideration. Accordingly, the claim of Smt. Suman Devi is hereby rejected for the reasons stated above, being devoid of merit.
