Item No. To consider and approve provisional rates for Hematology Cum Biochemistry Lab Test. 141.2

The Standing Committee was requested to approve the rates for Hematology and Biochemistry lab tests at PDUNIPPD as per <u>CGHS rates</u> issued by the Government of India, to maintain consistency with market standards and ensure the provision of cost-effective diagnostic services.
