The Meeting started with the customary welcome of the Hon'ble Chairperson and the worthy Members by the member secretary. After seeking the permission of the Hon'ble Chair, the agendas for the special meeting were taken up.

Item To consider the DPR for permanent building of CRC Jaipur

144.1 The building plans for CRC Jaipur were finalised with due provisions for PMDK (with concurrence of ALIMCO) and submitted to DEPwD on 12.06.2025. The same were approved by DEPwD vide e-mail dated 20.06.2025.

The preliminary presentation of DPR for permanent building of CRC Jaipur was done on 08.07.2025 and the observations of the worthy members were relayed to the NBCC officials and architects appointed by them vide email dated 09.07.2025.

The NBCC team (including their architects) presented the revised DPR again before the Standing Committee on 18.07.2025 duly addressing and incorporating the observations and suggestions given by the worthy members and submitted an estimate of Rs.27,29,40,485/- (Rupees Twenty-Seven Crore Twenty-Nine Lakh Forty Thousand Four Hundred Eighty-Five only) for the project. The queries of the worthy members were satisfied by the NBCC officials.

The Standing Committee considered and approved to approve and recommend the Detailed Project Report (DPR) to DEPwD with the estimate of Rs.27,29,40,485/- (Rupees Twenty-Seven Crore Twenty-Nine Lakh Forty Thousand Four Hundred Eighty-Five only) as submitted by the NBCC for the permanent building of CRC Jaipur.
