1. ABOUT NATIONAL COUNCIL FOR HOTEL MANAGEMENT AND CATERING TECHNOLOGY

The National Council for Hotel Management and Catering Technology (NCHMCT) was established in 1982 by the Ministry of Tourism, Government of India, to coordinate and regulate the growth and overall advancement of hospitality management education through its affiliated institutes. The Council has played a pivotal role in supplying professional and skilled human capital to the hotel and tourism industry through its academic programs.

NCHMCT offers a 3-year Bachelor's Degree programme in Hospitality and Hotel Administration (B.Sc. HHA) in collaboration with Jawaharlal Nehru University as the degree awarding University. These programs are offered through NCHMCT affiliated institutes across the country.

As of now, the academic network of NCHMCT includes:

- **21 Central Institutes of Hotel Management**
- **30 State Institutes of Hotel Management**
- **1 PSU Institute of Hotel Management**
- **2 Public-Private Partnership (PPP) State IHMs**
- **26 Private Hotel Management Institutes**
- **13 Food Craft Institutes**

All the above Hotel Management Institutes offer the above-mentioned degree program, under the academic umbrella of NCHMCT. The Food Craft Institutes offer Diploma and Certificate Courses under the academic umbrella of NCHMCT.

2. CAREER OPORTUNITIES FOR HOSPITALITY PROGRAM SUCCEEDORS

The global growth and expansion of the tourism industry have created numerous career opportunities for graduates in the field. As a result, students completing their hospitality education can look forward to a wide range of professional avenues, including:

Over 95% of graduates are successfully employed in the hospitality and allied service sectors through both on-campus and off-campus recruitment processes.

3. Program Details and Admission Procedures of B.Sc.(HHA) Programme

3.1 About the Programme:

This programme equips students with the necessary skills, knowledge, and attitude to effectively undertake supervisory roles in the hospitality sector. It includes comprehensive laboratory training to help students develop the required competencies in key operational areas such as Food Production, Food & Beverage Service, Front Office Operations, and Housekeeping.

In addition to practical skills, the curriculum also provides strong managerial inputs in areas including Hotel Accountancy, Food Safety & Quality, Human Resource Management, Facility Planning, Financial Management, Strategic Management, and Tourism Marketing and Management.

The B.Sc. HHA programme with a vegetarian-only option is also available at all affiliated Institutes of Hotel Management for students who wish to pursue training in vegetarian cuisine only. While the theoretical components of the programme are common to all students, separate practical sessions are conducted for those who have opted for the vegetarian track.

3.2 Duration of the Programme:

B.Sc. (Hospitality and Hotel Administration) programme is of 03 years duration.

3.3 Eligibility:

For Indian Nationals:

- A pass in 10+2 system of Senior Secondary examination or its equivalent with English as one of the subjects. Candidate must have passed English as a subject of study (core/elective/functional) in the qualifying examination.
- Intermediate or two-year Pre-University Examination conducted by a recognized Board/ University with English as one of the subjects.
- Those appearing in 10+2 or equivalent examination can also appear on provisional basis. However, the candidate should submit the proof for qualifying the examination by **30th September** of the admission year.

COMMON QUALIFYING EXAMINATIONS FOR INDIAN STUDENTS

- Plus two level examination in the 10+2 pattern of Senior Secondary education of any recognized Central/State Board, such as Central Board of Secondary Education and Council for Indian School Certificate Examination or State Boards of Secondary Education.
- Intermediate or two-year Pre-University Examination conducted by a recognized Board/ University.
- General Certificate Education (GCE) Examination (London/Cambridge/Sri Lanka) at the Advanced (A) level.
- High School Certificate Examination of the Cambridge University.
- Any Public School/Board/University Examination in India or in a foreign country recognized by the Association of Indian Universities as equivalent to 10+2 pattern of Senior Secondary education.
- H.S.C. Vocational Examination approved by NCVT and SCVT of concerned state.

3.4 Senior Secondary School Examination conducted by the National Institute of Open Schooling with a minimum of five subjects including English as one of the passing subjects, result of which should be available by **30.09.2026**.

3.5 Age Limit:

- There is no age bar to get admission in the Programme.

3.6 Medical Fitness :

All qualified candidates are required to submit a Medical Fitness Certificate from a Registered Medical Practitioner at the time of admission. The certificate must confirm the candidate's fitness to undertake the practical training prescribed in the programme and should be submitted in the prescribed format provided in Annexure-1.

3.7 Seat Allotment Procedure :

Candidates must register on the counselling portal – www.nchmcounselling.nic.in – by providing the required credentials and paying a non-refundable registration fee of ₹2,000. Upon registration, candidates will be able to fill in their choices of Institutes through the portal. Institute allotment will be done by the system based on a merit-cum-choice basis.

3.8 Reservations for Seat Allotment:

a. NCHMCT follows the reservation policy of the Government of India for filling seats in its affiliated Government Institutes under the B.Sc. (HHA) programme, as per the merit list of NCHM JEE results. The reservation percentages are as follows:

- EWS (Economically Weaker Sections - General): 10%
- OBC (Non-Creamy Layer): 27%
- Scheduled Caste (SC): 15%
- Scheduled Tribe (ST): 7.5%

b. Reservation for Persons with Disabilities (PwD): There will be 5% reservation for candidates with 40% or more disability, as defined in the Rights of Persons with Disabilities (Amendment) Act, 2016. However, the candidate must be physically capable of performing all practical tasks as prescribed in the programme. Refer to Annexure 1.1 for specific requirements related to practical classwork.

c. Reservation for Kashmiri Migrants (subject to notification from Ministry of Education) - One supernumerary seat in each Central Govt. Institute.

Practical to be carried by a student during the course duration:

The following practical tasks are essential components of the programme, and all candidates must be physically capable of performing them:

- i. Cutting and chopping of all vegetables and other ingredients prior to cooking.
- ii. Preparation of four dishes in each practical class, both in the Basic Training Kitchen and the Advanced Training Kitchen.
- iii. Cooking Indian menus in bulk quantities as a member of a team.
- iv. Performing all tasks in the Bakery and Confectionery section.
- v. Service of food and beverages, including flammable items, in the Training Restaurants.
- vi. Tasks in Housekeeping, including flower arrangement, bed-making, cleaning, stain removal, washing (using machines), ironing, use of calendaring machines, floor mopping, operating vacuum cleaners, and handling floor cleaning/polishing machines.
- vii. Computer operations, including room reservations using dedicated software.

3.9 Merit List:

An All-India Merit List of candidates shall be prepared based on the marks secured in the NCHM-JEE. In the event that two or more candidates secure equal marks, the merit shall be determined as follows:

- i) The candidate securing higher marks in the English component of the NCHM-JEE will be ranked higher.
- ii) If the tie persists, the candidate securing higher marks in the Service Aptitude component of the NCHM-JEE will be ranked higher.
- iii) If the tie still remains unresolved, the candidate who is older in age will be ranked higher.

COUNSELLING & OTHER ADMISSION PROCEDURES

3.9.1 ALLOTMENT OF SEATS THROUGH COUNSELLING

There shall be two rounds of Counselling (Online) on the basis of NCHM JEE merit (All India Rank) for eligible candidates only. The detailed process of Counselling shall be available in the website www.nchmcounselling.nic.in after declaration of result of **NCHM-JEE 2026**.

*Eligible candidates from the merit list of NCHM JEE, in order to participate in the Counselling process, will have to register & pay a one-time **non-refundable registration fees of Rs 2,000 in the counselling portal.***

3.9.2 First Round

- (a) The registered candidates will select their preferred institutes in the first round as per the schedule. Candidates may choose one or more institutes. Each candidate must fill in their choices carefully and only select those institutes they are willing to join. Seats will be allotted based on the candidate's NCHM JEE All India Rank, reservation category, and the preferences of the institutes chosen through the online system.
- (b) Candidates who are allotted a seat in the first round, based on their preferences, may confirm the seat by paying the Seat Acceptance Fee (SAF) of Rs. 20,000/- and uploading the required documents for online Document Verification at the Document Verification Centre (DVC). The SAF of Rs. 20,000/- is part of the first semester fee and will be transferred to the finally allotted institute.
- (c) Candidates who are allotted a seat in the first round but do not deposit the Seat Acceptance Fee within the counseling schedule for the first round will have their allotted seat automatically canceled. These candidates will then be eligible to participate in the last round against the available vacant seats.
- (d) Candidates who have deposited the Seat Acceptance Fee (SAF) in the first round of counselling but have not completed the document verification process for seat confirmation will have their allotted seat automatically cancelled. They will be eligible to participate in last round, and the fees already deposited will be adjusted if they participate; otherwise, the amount will be refunded.
- (e) If a seat is allotted and the candidate does not meet the eligibility criteria, such as educational qualifications, age, etc., the allotted seat will be automatically cancelled. The Seat Acceptance Fee (SAF), if deposited, will be refunded.
- (f) If a candidate registered in the first round is allotted a seat but is unable to produce the 12th Pass Certificate during document verification, they may still be considered provisionally, provided they submit valid proof of having appeared in the examination conducted by a recognized board. In such cases, the candidate must submit a written undertaking declaring that they will produce the original 12th Pass Certificate to the allotted institute by 30th September of the admission year. If the candidate fails to submit the certificate by the specified date, or is placed in a *compartment*

(i.e., has not passed one or more subjects and is required to reappear for them), the allotted seat will be automatically cancelled and the Seat Acceptance Fee will not be refunded.

- (g) If a candidate registered in the first round is allotted a seat based on the category under which they applied but is unable to produce the original category certificate during document verification, they may still be considered provisionally, provided they present sufficient supporting evidence of belonging to the same category. In such cases, the candidate must submit a written undertaking stating that the original category certificate will be submitted to the allotted institute by 30th September of the admission year. Failure to do so by the stipulated date will result in automatic cancellation of the allotted seat, and no refund of the Seat Acceptance Fee will be granted.
- (h) If a candidate registered in the first round and was allotted a seat based on the category they applied under but is found not to belong to that category during document verification, their category will be converted into General Category and their allotted seat will be cancelled. Now the candidate may participate in last round of counselling under General category only.
- (i) If a candidate is allotted, accepts, and confirms a seat in the first round of counselling but withdraws the seat within the stipulated date (i.e., before the processing of seat allotment for the Second/Final Round) through the online portal, both the allotted seat and the counselling registration shall stand cancelled. However, such a candidate shall remain eligible to participate in the Second (Final) Round of counselling. The Seat Acceptance Fee (SAF) of Rs. 20,000/-, if already deposited, shall be adjusted in the subsequent round.
- (j) If a seat is not allotted in this round, the candidate may participate in final round, and the registration fee will be carried forward.
- (k) Once the seat is accepted it shall be automatically treated as frozen.

3.9.3 Final Round of Counselling: -

- a. Candidates should note that the second round is the final round of counselling for admissions, and there will be no further rounds of counselling for seat allotment.
- b. Candidates who participated in first round, were allotted a seat, accepted it, and finalized the admission, but now wish to participate in the Final Round against available vacant seats, may do so. In case a seat is not allotted in this round, the earlier allotted seat will be retained. However, if the seat is upgraded in this round, the claim to the earlier seat will be automatically forfeited, and the candidate will have no further claim to the previously allotted seat.
- c. Candidates who have not registered or participated in the first round of counselling may register by depositing the registration fee of Rs. 2,000 through the portal. Since this is the last round and withdrawal is not permitted, candidates must also deposit the Seat Acceptance Fee (SAF) of Rs. 20,000 in order to access the choice-filling link for available vacant seats. The seat allotment process in this round will follow the same procedure as in previous rounds, except that withdrawal or surrender of the allotted seat will not be allowed.
- d. No withdrawal or surrender of seat and no refund will be permitted in or after this round.

3.9 Refund Rules

- a. The registration fee of Rs. 2,000 for participating in the counselling process is non-refundable.
- b. A candidate who has accepted a seat in the First Round of counselling may withdraw the seat by submitting an online request through the e-counselling portal and following the prescribed steps during the respective round. This withdrawal option will be available only until the end of the first round. Such candidates will receive a 95% refund of the Seat Acceptance Fee (SAF).
- c. There is no online option to withdraw an accepted or allotted seat after the First Round of counselling is over.
- d. A candidate who participates only in the Final Round, deposits the SAF, but is not allotted any seat, or is allotted a seat but declared ineligible, will be eligible for a 100% refund of the SAF.
- e. If a candidate participates only in the Final Round, is allotted a seat, and is found eligible, no refund will be provided if they choose not to accept the seat or wish to withdraw from the seat.

f. A candidate who was allotted and accepted a seat in an earlier round, participated in the Final Round, but did not receive an upgraded seat (i.e., the earlier seat is retained), and subsequently wishes to withdraw or surrender the seat, will not be eligible for any refund.

g. SAF Refunds for non-allotment of seats, if applicable, will be processed by the NCHMCT only directly to the bank account provided by the candidate during the online withdrawal process through the portal. Refunds will be issued within 60 days from the commencement of the Academic Session (AS) for the newly admitted batch. For this year, the tentative date for the commencement of the Academic Session is 27th July 2026.

h. Refunds can be requested by directly sending an email to jeenchm@gmail.com, No refund request will be entertained after 31st October 2026.

i. SAF Refunds will be processed only by 30th November 2026.

3.11 Inter – Institute Transfer / Migration

NCHMCT does not allow inter-institute transfer or migration on any ground during the entire duration of the course since the allotment of Institute is done on merit-cum-choice only. No request for transfer or migration will be entertained after allotment of seat.

4. Fees Structures

4.1 Fees Structures (for Government sponsored Institutes)

a. Candidates allotted a seat through NCHM JEE must pay the remaining first semester fee directly to the allotted institute, excluding the Seat Acceptance Fee (SAF) of Rs. 20,000, which has already been paid.

b. There is no fee concession for candidates belonging to reserved categories. However, they may apply for scholarships from the respective government authorities or other scholarship-granting agencies.

c. Caution money, locker fees, library fees, and any other applicable charges will be levied by the institute and must be paid separately after reporting to the finally allotted institute. Hostel fees are determined by the individual institutes and can be obtained from the respective institute websites.

Note:- The cities in India have been classified into three categories based on their status. Institutes of Hotel Management (IHMs) located in Category A and Category B cities have been granted the discretion to charge a higher rate of tuition fee. The categorization of cities and the maximum permissible increase in tuition fees are as follows:

Category	Cities where the IHMs are located	Maximum discretion allowed to the respective Board of the IHM
"A"	Delhi, Mumbai, Kolkata, Chennai, Bengaluru and Hyderabad	Maximum up to 40% in the Tuition fee component only.
"B"	Gandhinagar, Jaipur, Lucknow, Bhopal and Chandigarh	Maximum up to 24% in the Tuition fee component only.
"C"	Rest of the cities where the IHMs are located	No discretion

4.2 Fees Structures (for Private affiliated Institutes)

- Private Affiliated Institutes have the discretion to charge higher rate of tuition fee, not more than double of the standard tuition fee as stated in 4.1 above.
- Candidate are advised to obtain the fee structure, inclusive of other Institutional/ Activity fee of respective Institute from their websites.
- At the same time, candidates are advised to be aware of the availability of Hostel and Hostel Mess Charges of the Institute which differ from institute to institute.
