Record of discussion of meeting of the Committee on linking of e-Court with land records and registration data base held on 04th December 2020 through VC under the Chairmanship of Additional Secretary , Department of Land Resources

A meeting of the Committee on linking of e-Court with land records and registration data base was held on 04th December 2020 under the Chairmanship of Additional Secretary, Department of Land Resources through VC to discuss feasibility of linking of e-Court with land records and registration data base. The list of participants is at **Annexure I**.

At the outset, Additional Secretary, DoLR welcomed the participants and gave overall background of the performance of the Registering Property Indicator of Ease of Doing Business ranking of the World Bank and highlighted importance and weightage of linking e-Court with land records and registration data base in improving overall ranking. Sh. Rajiv Goel, Scientist 'F',NIC-DoLR made a small presentation on integration of eCourt MIS with LR & Property MIS before the committee.

Shri G. Raghavender, Joint Secretary, Department of Justice, briefed about the functioning of eCourt Committee of the Supreme Court and requested Sh. S.B.Singh ,DDG & HOG(e-courts) to present point of view of the eCourt Committee on the issue.

Sh. S.B.Singh ,DDG & HOG(e-courts) stated that the issue is how to capture land related data in the e Court system. He informed that each court case is assigned an unique CNR number and in each land related cases, District Magistrate and revenue authorities are made party. As such revenue functionaries can make entry of the details of land against CNR number. The similar exercise is being used for exchange of data with ICDS system or the Police database in the States. At present eCourt system don't capture Tehsil & Village as entity, which are required for identification of a Land Parcel (To identify a land Parcel minimum requirement is complete location i.e. State, District , Tehsil , Village & then Khasra no. / Property no. , as same Khasra no. / Property no can be in other villages). He suggested for a common portal / API and advocated for immediate pilot testing. Advocates can add data relating to land online but what about manual entries.

Additional Secretary stated that it is not feasible for revenue functionaries to enter land details against the CNR number. At present eCourt system don't have land Parcel related key field without which integration between two systems is not possible.

Additional Secretary (LR) mentioned that as locating the land parcel, Khasra number is the key field, State, District , Tehsil , Village & then Khasra no. / Property no has to be captured in eCount system while making entries of the case.

Shri Ashish J. Sriradhonkar, Scientist "G" NIC, e-court, Pune stated that khasara number can be made a key parameter for interlinking two software and DoLR should provide data through APIs.

DDG & HOG(e-courts) suggested that these parameters should be through dropdown list to minimize errors. He also appreciated unique khasara no. model of U.P.

NIC team Maharashtra informed that they are having data / information in dropdown format based on LGD code and the same can be shared. States of Haryana and Uttar Pradesh also have provision for sharing of data such as district, tehsil, village, ghata number & then owner name, plot area and are being shared with other departments through APIs.

It was decided that Revenue Departments of Government of Haryana, Uttar Pradesh and Maharashtra would share data with the e-courts team through APIs so that pilot testing can be conducted in these three States to start with the scheme of things.

The meeting concluded with a vote of thanks to the chair.
