Sir / Madam,

I am directed to refer to the above-mentioned subject and to forward a summary of components wise performance of States/UTs under DILRMP and to request you to review and expedite the physical progress of various components of DILRMP as below.

(1) Computerisation of Land Records:

- (a) States/UTs where No Progress has been made and needs special focus and intervention at higher level are: J&K and Manipur.
- (b) States/UTs which are lagging behind other states and needs extra efforts and monitoring at higher level to achieve the mile stone are: Assam, Bihar, Chandigarh, Goa, Kerala, Tripura.
- (c) States/UTs where significant progress has been made and work can be completed with minimum efforts are: Chhattisgarh, Daman & Diu, Haryana, Puducherry, Punjab, Sikkim, Tamilnadu, Uttarakhand and Uttar Pradesh.

(2) Digitization of Cadastral Maps:

- (a) States/UTs where No Progress has been made and needs special focus and intervention at higher level are: J&K, Manipur, Karnataka, Chandigarh, Delhi, Daman & Diu ,Lakshadweep, Maharashtra, Rajasthan and U.P.
- (b) States/UTs which are lagging behind other states and needs extra efforts and monitoring at higher level to achieve the mile stone are: Andaman & Nicobar Islands, Andhra Pradesh, Gujrat, Uttarakhand.
- (c) States/UTs where significant progress has been made and work can be completed with minimum efforts are: Chhattisgarh, Haryana, Punjab, Kerala, Telangana and West Bengal.
- **(3) Integration of Cadastral Map with RoR**: All the states (except Goa, Odisha and Tripura) need to expedite this activity.

(4) Computerisation of Registration:

- (a) States/UTs where No Progress has been made and needs special focus and intervention at higher level are: Chhattisgarh, Meghalaya, U.P.
- (b) States/UTs which are lagging behind other states and needs extra efforts and monitoring at higher level to achieve the mile stone are: Goa, Daman-Diu.
- (c) States/UTs where significant progress has been made and work can be completed with minimum efforts are: Assam, Haryana, Himachal Pradesh, Punjab, Sikkim and Uttarakhand.
- (5) Connectivity between SROs & Integration of Land Records and Property Registration: All the states (except A.P., Dadar and Nagar Haveli, Gujrat, Jharkhand, Kerala, Maharashtra, Delhi, Telangana, Odisha and Tripura) need to expedite this activity.

You are therefore requested to review component wise progress on regular basis and take urgent required action in respect of the components where progress is not satisfactory.
