Sir/Madam,

As you may be aware that this Department has set the target for the financial year 2019-20 for Output-Outcome framework under the Digital India Land Records Modernization Programme (DILRMP) in consultation with NITI Aayog and shared with all States and UTs. Further department has proposed to the Sectoral Group of Secretaries on Rural and Agriculture to develop Integrated Land Information Management System (ILIMS) in 50 identified districts. You are aware that ILIMS is a comprehensive transparent land governance system to enable land related information in single window. It can be achieved, if, all the land records data are computerized including registration process and their integration. Additionally, a complete ILIMS System requires integration with banks/financial institutions, revenue courts etc.

2. Digital India Land Record Modernization Programme (DILRMP) has also been identified under Output-Outcome Framework for monitoring by NITI Aayog. The progress made under various components viz. Computerization of Land Records (Digitization of Cadastral Map and RoRs) , RoRs integrated with Cadastral Maps/FMBs, Computerization of Sub-Registrar Offices (SRO), SRO connected with Revenue Offices and Establishment of Modern Record Rooms have been monitored regularly. The State-wise target set against these indicators has already been conveyed to all States/UTs vide this Department's letter No.15015/01/2018-LRD dated 10.04.2019 (copy enclosed). A copy of the Output-Outcome Framework 2019-20 sent to NITI Aayog is also enclosed herewith.


3. For monitoring the progress made on various components mentioned above under DILRMP, 50 districts are to be identified by the States/UTs in the country with the target to complete all above mentioned components/activities by the end of 2019-20 on priority basis. The smaller States may identify 1 district and bigger States may identify 2 districts for the purpose of achieving Integrated Land Information Management System (ILIMS) as mentioned above.

4. In view of the above, State/UTs are requested to kindly identify the districts as explained above for completion of all components of DILRMP required for achieving Integrated Land Information Management System (ILIMS) in the identified districts and furnish the information in this regard to this Department on utmost priority. If some districts have already been achieved

the target during 2019-20, the same may also be informed. Further, as soon as any district is achieved its target in future, the same may also be shared and uploaded on MIS regularly.


