Minutes of the *Bhumi Samvaad* - Review Meeting of DILRMP held under the Chairmanship of Secretary, Department of Land Resources on 24.06.2022

- **1.0** A Review meeting of Digital India Land Record Modernization Programme (DILRMP) was held with States/UTs on 24.06.2022 under the Chairmanship of Secretary, DoLR at India Habitat Centre (IHC) New Delhi..
- 1.1 List of Participants is annexed at Annexure I
- 2.0 Shri Hukum Singh Meena, Additional Secretary, Department of Land Resources (DoLR) welcomed Secretary (DoLR), AS&FA, Senior Officers /delegates from States/UTs and other participants to the meeting. He underlined the need and importance of DILRMP and emphasized for timely completion of its various components by the States/UTs. He mentioned that land acquisition is the first and important step towards setting up of any Industry for economic activity in the country. AS(LR) mentioned that the Department has given commitment to the highest authority for completion of basic components of DILRMP by March, 2023 which includes: Computerization of Record of Rights (RoR), Digitization and Geo-Integration of RoR and Cadastral Map, of Cadastral Maps, referencing Computerization of Registration Offices and their integration with Tehsils. He briefed about the new initiatives taken by the Department which are of International participants to adopt these initiatives in their standards and requested States/UTs. He informed that the Department has achieved several milestones and received distinguished awards under the guidance of Secretary, DoLR.
- 3.0 Shri Ajay Tirkey, Secretary, Department of Land Resources in his opening remarks, stated that substantial progress has been made in various components of DILRMP across the country. He emphasized the need to sit together and analyze the work which has been completed and move towards completion of remaining work. He stated that the country is on the cusp of big transformation across the States . There is a need to stitch the components together and move ahead. He stated that certain States (Tripura, Madhya Pradesh, Sikkim, Gujarat, Odisha, Rajasthan, West Bengal, Assam and Jharkhand) have done exceedingly well in other States/UTs may interact with these States to learn how they could achieve the targets.
- 3.1 Secretary(LR) mentioned that this year, Department is focusing on Georeferencing of cadastral maps, which is a must for generating Unique Land Parcel Identification Number (ULPIN). Geo-referenced cadastral maps and ULPIN are extremely important, while dealing with issues like boundary disputes etc. There are certain States like Karnataka, Goa, Gujarat, Sikkim, Madhya Pradesh, Jharkhand which have done well in Geo-referencing of cadastral maps. However, there are certain States like Punjab, Chhattisgarh and Tamil Nadu where the work is lagging behind. There are some areas of concern especially from North East and Ladakh.

- 3.2 With regard to Computerization of SROs, Secretary(LR) stated that good work has been done in most states; certain States like Meghalava, Mizoram, Manipur, Arunachal Pradesh, Nagaland and Ladakh needs to put in efforts for early completion. He stated that 19 States have moved ahead in rolling out of ULPIN and added that 7 States are ready for further rolling out, keeping in view their level of preparedness. He requested Andaman & Nicobar, Karnataka, Kerala, Manipur, Delhi, Puducherry and Telangana to expedite the preparedness to roll out ULPIN and requested other States/UTs to move ahead for ULPIN roll out. NGDRS he informed that 15 States have implemented. He stated that the States having other excellent registration platforms must ensure that all 11 modules of NGDRS are available in their platforms so as to have a uniform and standard Registration System across India leading to "One Nation, One Registration Software". He explained the benefits of Transliteration Software being developed by the DoLR in association with C-DAC Pune to have land record data in all 22 Regional languages. Pilot test for Transliteration of Land Records is proposed in 8 States/UTs. He briefed the gathering about the proposed *Matribhoomi* portal, which is aimed to provide unified services across India for citizens and stakeholders. He mentioned about the importance of e-Courts and Land Acquisition portal. He stated that 17-18 States have already filled in data in the Land Acquisition portal and requested other States/UTs to fill in the data so as to have all information related to land acquisition cases at one place for enabling better monitoring and timely completion of various projects.
- 3.3 Secretary(LR) informed about the Iconic Village Awards and National Land Records Management Awards initiated by DoLR. DoLR has received so far, nominations from 6 States for Iconic Village Awards and from 19 States for National Land Records Management Awards. He urged remaining States/UTs to send their nominations for these two awards. He stated that the idea to initiate these awards is to push the States/UTs towards saturation of DILRMP components across India and recognize the good performance of Patwaris, Sarpanch/Gram Pradhan and other officers at Tehsil, District and State level. He also informed about performance based monthly district grading viz. Platinum, Gold and Silver based on performance in six parameters under DILRMP viz. (i) Computerization of RoR (ii) Digitization of Cadastral Maps (iii) Linkage of RoR with Cadastral Maps/FMBs (iv) Computerization of Registration (v) Integration of SRO with Land Records and (vi) Modern Record Room.
- 4.0 Smt. Leena Johri, Additional Secretary & Financial Advisor, MoRD provided guidance on the Ministry of Finance OM dated 09.03.2022 regarding new procedure of fund flow under Central Sector Scheme. She explained about designating Central Nodal Agency, opening of Central Nodal Account in a scheduled commercial bank and zero balance accounts of Sub Agencies in the same bank and their mapping on PFMS, setting of drawing limits of Sub Agencies, depositing of interest accrued in Consolidated Fund of India, refund of unspent balance from Sub Agencies' account to account of CNA, utilization of at least 75% of fund released earlier and submission of UCs before further release, etc. and requested to draw a channel in right direction to utilize unspent fund and take expeditious action at State/UT level. She mentioned

that the Department needs to map CNA and Sub Agencies accounts in PFMS through unique ID and asked States/UTs to ask their PFMS and Accounts teams to get aligned with Department and flag any issue immediately to the knowledge of the Central PFMS team. She emphasized to review the status of onboard on PFMS on daily basis or if their system is having features equivalent to PFMS they can integrate with PFMS. She informed that Banks have been given separate instruction in this regard and they are eager to take it up and put their IT systems accordingly. Ministries/Departments would release fund to CNA based on their demand and their unspent balance. She emphasized on refund of interest to Consolidate Fund of India and submit report in prescribed format shared with States/UTs duly signed and stamped by the Secretary or HOD of the State, without which the Ministry will not be able to release the first tranche of 25% of the funds in the current financial year.

- Status of States/UTs having huge unspent balance viz. Andhra Pradesh, 5.0 Bihar, Rajasthan, Himachal Pradesh, Uttarakhand, Jammu & Kashmir, Karnataka, Assam, were reviewed. Andhra Pradesh assured to utilize Rs.50.00 crore (Rs. 25.00 crore each under Modern Record Room and survey/Resurvey by September, 2022. Bihar stated that there is reconciliation problem. Earlier there was a single account and all money was kept in it. Later the separate account has been opened for the DILRMP. Actual balance is Rs.35.21 crore maximum of which pertains to Survey/Resurvey which will get updated on PFMS. Himachal Pradesh stated that out of Rs.21.00 crore, Rs.19.00 crore is under Survey/Resurvey. As per State Revenue Act, the Survey/Resurvey can be done after a gap of 40 years due to which State is going slow in doing Survey/Resurvey. The issue is under active consideration of higher authorities in the State and a decision is to be taken within a month. Uttarakhand stated that Rs. 12.00 crore is under MRR and will be utilized by 2022 remaining Rs.11.00 crore is for Survey/Resurvey recently UT of Jammu & Kashmir stated that major unspent amount is under released. Survey/Resurvey. UT is not getting good agency despite several tenders and requested for a panel of agencies from DoLR. It was informed by AS(LR) that in 2016 DoLR empaneled agencies which can be provided. Secretary, LR stated that if UT desires a Central team may be sent to Jammu & Kashmir for providing Karnataka stated that full fund has been utilized and UC submitted however there are certain issues regarding PFMS updation which will be resolved with Central PFMS team. The status of REAT implementation was reviewed and the States/UTs which have not complied with REAT implementation were requested to take necessary in this regard as no fund would be released to them without REAT implementation. As requested by the States/UTs, it was agreed to organize a training programme on REAT implementation shortly for States having issues.
- 6.0 AS(LR) made a presentation on progress under various components of DILRMP. He highlighted component wise fund allocation for DILRMP for the period 2021-22 to 2025-26 and fund released during 2021-22 and emphasized on massive capacity building for patwaris and other field level functionaries and asked the State/UTs representatives to send proposals to DoLR. He informed about the newly approved components of DILRMP viz. Computerization of Revenue Court Management System and Integration of Aadhaar number with the land record database on consent basis. Component wise physical progress under

Computerization of Land Records, Cadastral Maps digitized and Georeferenced, Cadastral Maps linked to RoR, Computerization of Sub Registrar Offices (SROs), Connectivity of SROs with Revenue Offices and Modern Record Room (MRR) were also covered in the presentation. He assured the States/UTs that there will be no shortage of fund from DoLR as the Department is committed to complete the computerisation/ digitization of basic components by March, 2023. He stated that most of the states have completed Computerization of RoR and Map Digitization and emphasized that Aadhaar Integration is the priority and requested the representatives from States/UTs to send proposals. He also requested to complete the integration of RoR with Tehsils and MRR on priority basis. Copy of presentation is attached at **Annexure-II**.

- 7.0 State/UT wise discussion points are as under:
- **7.1 Jammu & Kashmir:** Dr. Rajiv Ranjan, Commissioner (Survey & Land Records) informed that Computerization of Land Records will be completed by 15th August, 2022.
- **7.2 Manipur:** Shri Chandam Babo Singh, Deputy Secretary (Revenue) informed that in areas where Land Revenue Act is enforceable, 90% computerization has been completed. Rest of work will be completed in next 100 days.
- **7.3 Assam:** Shri Nabajit Pathak, ACS, Additional Director (Land Records) informed that there are 07 Districts in 6th Schedule area which have not computerized their Land Records. In remaining Districts, the work has been completed. Areas which are under Autonomous District Councils have issues in North East Region as the land records are with them.
- **7.3.1** In response, AS(LR) mentioned that States may try to convince these Councils that they will get the benefit of PM Kisan Samman Nidhi, Paddy procurement and other welfare Schemes of the government only if they computerize their land records, as done by Mizoram.
- **7.3.2** Secretary, DoLR stated that the department has been trying to address the issues for quite some time and suggested for setting up of a Task Force for these States for resolving the issues.
- **7.4 Chandigarh:** Shri Amit Kumar, ADC informed that the work of Digitization of Cadastral Maps of 25 villages has been assigned to an agency and will be completed by July, 2022.
- **7.5 Maharashtra:** Shri N.K. Sudhansu, Settlement Commissioner informed that Digitization of around 5 crore lowest parcel map and Tippans will be completed by December, 2023 through State Govt. fund of Rs.150.00 crore. In 6 Districts linking of RoR with Cadastral Maps will be completed in next 3-4 months. State needs to correct the data of Geo-referenced Cadastral Maps on MIS.

- **7.5.1** In response, AS, LR stated that Geo-referencing of Cadastral Maps must be done by all as it is a part of Digitization of Cadastral Maps.
- **7.6 Puducherry:** Shri M. S. Ramesh Director (Survey) informed that 100% Computerization of RoR and Digitization of Cadastral Map has completed and are online accessible to public but the same is not getting reflected in MIS.
- **7.6.1** Secretary,(LR) directed Director (LR) and Sr. Technical Director (NIC) to look into all such cases where actual performance is not getting reflected in MIS.
- **7.7 Tamil Nadu:** Smt. Kalaiselvi Mohan, Additional Director informed that the linking of Cadastral Maps to RoR has been completed but they are having issues in updation in MIS.
- **7.8 Tripura:** Shri Bhaskar Dasgupta, TCS Gr.I informed that out of 45 MRR, 43 completed and remaining 2 are under progress.
- 8.0 Shri P.C. Prasad, Director, DoLR made presentation on the innovative initiatives of the DoLR viz. Unique Land Parcel Identification Number (ULPIN) and National Generic Document Registration System (NGDRS). He stated that ULPIN has been Pilot tested and subsequently rolled out in 20 States/UTs. Pilot test is being done in 7 States/UTs viz. A&N Islands, Karnataka, Kerala, Manipur, NCT of Delhi, Puducherry and Telangana and in Himachal Pradesh it is under process. 8 States/UTs are yet to take steps of Pilot test of ULPIN viz. Arunachal Pradesh, Chandigarh, Ladakh, Lakshadweep, Meghalaya, Uttarakhand, Uttar Pradesh and West Bengal. Puducherry & Kerala informed that they will rollout ULPIN in July, 2022. As regards NGDRS, he informed that it has been rolled out in 15 States/UTs and out of these it is fully implemented in 8 States viz. Punjab, Goa, Jharkhand, Himachal Pradesh, A&N, J&K, Tripura and Ladakh. 16 States are yet to initiate action for implementation of NGDRS. Copy of presentation is attached at Annexure-II.
- **9.0** Puducherry and Andhra Pradesh stated that they will roll out NGDRS by 15th July, 2022.
- **9.1 Punjab** informed that they have noted 40% increase in revenue collection after implementation of NGDRS in the State and started e-stamping at value of Rupee one which was Rs.20,000 earlier.
- **9.2 Haryana** informed that their legacy system is exactly like NGDRS and soon they will port to NGDRS with the assistance of NIC Pune team.
- **9.3** Odisha informed that their software is having all 11 modules of NGDRS and a pilot can be done in one SRO.
- **9.4 Sikkim** stated that they will work on a pilot in Gangtok with the help of NIC Pune team.

- 10.0 Dr. Ajay Kumar, Director, C-DAC Pune made a presentation on Transliteration of Land Records. He informed that CDAC Pune conducted a Trailing Programme on the subject from 15-17 June, 2022 in which representatives from four States viz. Maharashtra, Gujarat, Tripura and Uttar Pradesh participated. Representatives from Tripura, Gujarat and Maharashtra stated that they will be ready for pilot test by 15th July, 2022. Director, CDAC agreed for conducting another training for other States/UTs viz. Sikkim, Bihar, Puducherry, Tamil Nadu, J&K, Rajasthan, Assam, Uttarakhand, Goa, Chhattisgarh and Jharkhand as requested by participants from these States/UTs after 4th July, 2022. Copy of presentation is attached at Annexure-III.
- **11.0** Dr. Pawan Kotwal, Principal Secretary, Revenue, Ladakh made a presentation on implementation of NGDRS in the UT of Ladakh. Copy of presentation is attached at **Annexure-IV.**
- **12.0** Dr. Rajiv Ranjan, Commissioner (Survey & Land Records), J&K made a presentation on implementation of ULPIN in the UT of J&K. Copy of presentation is attached at **Annexure-V**.
- **13.0** Shri Rajendra Vijay, Settlement Commissioner (Revenue), Rajasthan made a presentation on Establishment of Ground Control Network, conducting Survey/Resurvey and Updation of the Survey & Settlement (Records) operations in Rajasthan. Copy of presentation is attached at **Annexure-VI**.
- 14.0 Secretary, DoLR, in his concluding remarks, made the following points:
 - i. All the States/UTs should work expeditiously for completion of Computerization of RoRs and Digitization with Georeferencing of Cadastral Maps by March, 2023.
 - ii. All the States/UTs should aggressively work towards complete roll out of NGDRS and ULPIN by March, 2023.
 - iii. Transliteration of Land Records to be rolled out in all States/UTs by March, 2023. C-DAC will organize training session of three days for 8-10 States.
- iv. States/UTs should roll out linking of e-Courts with Revenue Courts in year 2022-23 itself.
- v. Land Acquisition portal should be updated by States/UTs by 31st August, 2022.
- vi. Opportunity will be given to other states on making Presentations on Best Practices in next meetings/workshops to apprise about their success stories so that others may get benefitted from their journey and for knowledge sharing amongst the States/UTs.
- vii. States/UTs that have not sent nominations for National Land Records Management Awards and Digital Land Governance Iconic Village and Panchayat Awards, may expedite their nominations.
- viii. All States/UTs to utilize fund at the earliest and make entry on PFMS also.
- ix. All States/UTs to update MIS of DILRMP and record performance on regular basis.
- x. All States/UTs to nominate a nodal officer for DILRMP related matters and send details to the DoLR.
- xi. All States/UTs should send success stories of DILRMP by August 2022 for Annual Publication.
