Sir,

In continuation of this Department's letter of even number dated 30.11.2017(copy enclosed) regarding implementation of LGD codes in Land Records and Registration databases of the States/UTs for making them compatible with Digital India Land Records Modernization Programme – Management Information System (DILRMP-MIS); I am directed to say that Ministry of Panchayati Raj maintains the Local Government Directory (LGD) application which is a standard location directory of all administrative units (district/block/gram panchayat/villages/urban local bodies etc.) that also provides an online mechanism for updating the same. The use of LGD and its codes helps in the inter-operability of data among Ministries/Departments and States/UTs. Adoption of LGD by all Union Ministries/ Departments and States/UTs Government has also been mandated by the Government

2. In order to adopt LGD application and its codes in the data collection process for Census 2021, all the States/UTs are requested to coordinate with respective NIC offices to expedite updating and validating of LGD codes before 31st December 2019.

Subject: Implementation of LGD Codes in Land Records and Registration databases of the States/UTs for making them compatible with Digital India Land Records Modernization Programme - Management Information System (DILRMP-MIS).

Sir,

Department of Land Resources (DoLR) has been using the DILRMP online MIS hosted at <http://dilrmp.nic.in> for regular monitoring of implementation of the Programme, since the inception of the programme in 2008-2009.

2. It is envisaged that this MIS data will be used as a common tool by both the centre and the state, for not only monitoring progress of implementation of DILRMP but also for exchanging the data with various departments for their respective planning needs and other programmes of the States/ UTs, thereby the ownership of the data can be established and data discrepancies can be avoided.

3. It must be relevant to mention that data available on MIS are being extensively used for preparing replies to Parliamentary questions, inputs to other departments/ central ministries like NITI Aayog, Ministry of Agriculture & Farmer Welfare, Ministry of Chemicals & Fertilizers, Direct Beneficiary Transfer Mission etc. and therefore need for exchange of data in the electronic format both from the DILRMP-MIS and vice-versa.

4. In order to ensure seamless integration of this MIS system with other systems, to begin with, the location codes used in the respective States/ UTs for State, district, sub-district and revenue village in the Land Record databases must be made compliant with codes of Local Government Directory (LGD) being maintained by Ministry of Panchayati Raj. DILRMP-MIS database is LGD compliant.

5. In case there are any new LGD codes' requirements owing to additions at the district, sub-district and revenue village, such a list may also be furnished Statewise to this department for taking it up with the Ministry of Panchayati Raj.

6. All the States/UTs are requested to do the needful at the earliest and send the compliance report to this department.
