CIRCULAR

Subject: Filling up of one post of Junior Accounts Officer/ Accountant in the Department of Land Resources, Ministry of Rural Development on Deputation/ Absorption basis - reg.

Applications are invited to fill up one post of Junior Accounts Officer (JAO)/ Accountant in the pre-revised pay scale of Rs.5500-175-9000/ Pay Matrix Rs.35400-112400 (Level 6 of 7th CPC) in the Department of Land Resources on 'deputation/absorption' basis from officials of the Central Government having the qualifications and experience as mentioned in Annexure-I.

2. Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organisation/ Department of the Central Government shall ordinarily not exceed three years. The maximum age limit for appointment by deputation/absorption shall be not exceeding 56 years as on the closing date of the receipt of the applications.

3. The officer selected will have the option to draw his pay plus deputation allowance in accordance with the Department of Personnel & Training O.M. No. 2/12/87-Estt. (Part-III) dated 29.4.1988 as amended from time to time or to have his pay fixed in the scale of posts as per rules /orders on the subject.

4. It is requested that the applications of the eligible and willing officers and who can be spared immediately may be forwarded in the prescribed proforma (Annexure-II) alongwith up-to-date APAR dossier, vigilance clearance and Integrity Certificate.
