Monthly summary of important activities of Department of Land Resources during January, 2023.

A review meeting with States/UTs was held on 30.01.2023 under the chairmanship of Secretary, DoLR through Video Conference on the Roll out / Implementation of Bhu-Aadhar/Unique Land Parcel Identification Number(ULPIN) across the country and Proof of Concept (PoC) of Matribhoomi Geoportal in select districts of 11 States and UTs. The Department is fast tracking Bhu Aadhar or ULPIN because of the immense benefits it will give to all Sectors of Government.

- 2. ULPIN or Bhu-Aadhar (for Property Cards under SVAMITVA) was rolled out in Ladakh on 20th January, 2023 by Hon'ble Lt. Governor, UT of Ladakh in the presence of Secretary, DoLR though VC. Now, a total of 26 States/UTs have adopted/rolled out the ULPIN initiative.
- 3. States/UTs like Andhra Pradesh, Gujarat, Chandigarh, Tamil Nadu, Uttar Pradesh and Haryana have started sharing registration data with NGDRS(Online Registration) Portal, making total coverage of States /UTs under NGDRS to 26.
- 4. A meeting on 2nd Implementation Support Mission (ISM) of World Bank Assisted REWARD Project was held on 27.01.2023 under the chairmanship of Secretary, DoLR through Video Conference with World Bank Team. NPMU Experts and Senior Officers of DoLR and NRAA participated in the discussion.
- 5. Secretary, DOLR along with Senior Officers visited Mumbai to review the progress of implementation of Watershed Projects in Maharashtra on 12.01.2023. Chief Secretary, Maharashtra and Secretary, DoLR strategized measures for Maharashtra to claim their next tranche during CFY 2022-23. As a consequence of close monitoring and strategizing, a total amount of Rs.108 crore could be released to Maharashtra.
- 6. Joint Secretary(Watershed Management) took a meeting with the States/UTs for reviewing implementation of WDC-PMKSY 2.0 scheme through VC on 03.01.2023. He addressed the workshop on "Strategies for building community based institutions and protocols for sustainable watersheds" through VC on 23.01.2023.
- 7. Senior Officers of the Department visited States of Rajasthan, Tripura and Uttar Pradesh for reviewing the progress of implementation of WDC-PMKSY 2.0 scheme during January 2023.
- 8. Under Watershed Development Component of the Pradhan Mantri Krishi Sinchayee Yojana (WDC-PMKSY), 6376 projects have been completed till date out of the total 6382 Projects 99% in all. End line evaluation of 5672 projects has been received till now.

- 9. The current status of progress (cumulative) of the different components of Digital India Land Records Modernization Programme(DILRMP) is as follows:-
 - (i) Computerization of Land Records of 6,22,106 Villages completed.
 - (ii) Computerization of Registration 4,905 SROs completed.
 - (iii) Digitization of 1,18,98,063 Cadastral Maps/FMBs/Tippans completed.
 - (iv) Integration of Revenue and Registration 4,043 SROs with land records completed.

(v) Establishment of Modern Record Rooms in 3,184 Tehsils completed.
