

Monthly Summary of important activities of Department of Land Resources during December, 2023

1. A National Workshop on "Cactus for Green Economy in Watershed Projects" was organized by Department of Land Resources (DoLR) at Bharat Mandapam, New Delhi on 22.12.2023. Hon'ble Minister of Rural Development & Panchayati Raj addressed the gathering through VC. DoLR signed a Memorandum of Understanding (MoU) with the ICAR, MoA&FW, ICARDA and Government of Rajasthan on Collaboration in Promotion of Spineless Cactus cultivation & its Economic Usages under WDC-PMKSY 2.0. About 200 delegates from 15 State Governments/UTs, Senior officers of Central line Ministries/Departments, Industry experts, etc., participated in the meeting.
2. Secretary (LR) participated in the session on "Land & Property" of the 3rd National Conference of Chief Secretaries on 29.12.2023.
3. As part of the Viksit Bharat Sankalp Yatra aimed to raise awareness through outreach activities to achieve saturation of various Government Schemes in States / UTs, Department of Land Resources organized distribution of Abhinandan Patras (Felicitation Certificates) to eligible villages in States/UTs. The programme included felicitation of Gram Panchayat / Village level functionaries like Patwari/Lekhpal/Mandal and Gram Panchayat functionaries like Sarpanch for achieving 100% Digitization of Land Records (as per schedule of Viksit Bharat Sankalp Yatra through the villages) under the Digital India Land Records Modernization Programme (DILRMP). As per the reports received from the States, Abhinandan Patras were distributed in 91201 Gram Panchayats as on 31st December 2023. Secretary (LR) and Senior officers of the Department visited selected villages in Jharkhand, Odisha and Tripura during the month and participated in the Viksit Bharat Sankalp Yatra.
4. A Core Technical Advisory Group (CTAG) meeting was held under the Chairmanship of Secretary (LR) on 20.12.2023. The meeting discussed and recommended technical proposals received from Chhattisgarh and Andhra Pradesh Governments on Survey related issues.
5. Unique Land Parcel Identification Number (ULPIN) / Bhu-Aadhar has been rolled out in States of Karnataka and NCT of Delhi during the month of December, 2023 and they have assigned Bhu-Aadhaars to about **85 lakhs** land parcels. As of now, 29 States / UTs have rolled out ULPIN Numbers in their respective States/UTs. Further, pilot testing has been done in 4 States / UTs namely Puducherry, Telangana, Manipur and Andaman and Nicobar Islands. As regards National Generic Document Registration System (NGDRS), it has been rolled out in 18 States / UTs and sharing of data with National Portal through User Interface / API done in 12 States/ UTs.
6. A meeting of World Bank Review Mission under REWARD program was held under the Chairmanship of Joint Secretary (WM) on 07.12.2023. Representatives from World Bank, National Rainfed Area Authority, ICRISAT, MANAGE and NRSA participated in the meeting.
7. Secretary (LR) held a meeting with Secretary, Department of Justice and his team regarding integration of e-Courts with Land Records Database.
8. Department of Land Resources participated in the 'Good Governance Week' celebrations organized by Department of Administrative Reforms & Public Grievances (DAR&PG) in New Delhi from 19-20th December, 2023. Department of Land

Resources took part in the Good Governance exhibition, highlighting the 'Best Practices' taken up by the Department during the Special Campaign 3.0.

9. A meeting of the Data Strategy Unit of the Department was held on 06.12.2023 to explore ways to improve the quality of data.

10. Under Watershed Development Component of the Pradhan Mantri Krishi Sinchayee Yojana (WDC-PMKSY), **6376** projects have been completed till date out of the total 6382 projects {8214 (Sanctioned) - 1832 (Transferred to State)}. End line evaluation of 6120 projects has been completed till now.

11. The current status of progress (cumulative) of the different components of Digital India Land Records Modernization Programme (DILRMP) is as follows: -

- i. Computerization of Land Records of **6,25,137** Villages completed.
- ii. Computerization of Registration **5,060** SROs completed.
- iii. Digitization of **2,52,51,446** Cadastral Maps/FMBs/Tippans completed.
- iv. Integration of **4,669** SROs with land records completed.
- v. Establishment of Modern Records Rooms in **3,461** Tehsils completed.
