

Monthly Summary of important activities of Department of Land Resources during February, 2024

1. Department of Land Resources organized a two-day National Conference of State Revenue/ Registration Secretaries and Inspector Generals of Registration (IGRs)- **Bhumi Samvaad VIII** on "**Sharing of Best Practices in Land Management Modernization**" on 8th and 9th February, 2024 at Vigyan Bhawan, New Delhi. The purpose of the Conference was to showcase good practices by States on modernization of land management including land records digitization. The meeting was chaired by Shri Giriraj Singh, Hon'ble Minister of Rural Development and Panchayati Raj. Minister of State (RD&Steel), MoS (RD, CA,F&PD), MoS (Panchayati Raj) were present in the inaugural function. Senior Officers of Revenue and Registration from States/UTs, Officers from central Ministries/ Departments concerned, experts from various Institutions, other stakeholders participated in the Conference.
2. The Department held a review meeting with States on **WDC-PMKSY** including expenditure, springshed development, MIS and other related issues through VC on 1st February 2024. Secretary (LR) reviewed the progress of **WDC- PMKSY 2.0 in Uttar Pradesh** on 15th February 2024.
3. A meeting was held by Secretary (LR) on 21stFebruary 2024 with the representatives of International Centre for Integrated Mountain Development (ICIMOD) on **Springshed Development** under WDC- PMKSY 2.0. Two review meetings were held during the month with States on **Spineless Cactus Cultivation**. Secretary (LR) held two meetings on **REWARD programme** on 6thand 16th February with World Bank, NRAA and States concerned.
4. Discussions were held by Secretary (LR) with BISAG-N team on 29.02.2024 to examine the feasibility for providing a basic thematic layer of **Cadastral maps in PM-Gati Shakti portal**.
5. A meeting was held by Additional Secretary (LR) with members of e-Courts Committee of the Supreme Court on 28.02.2024 regarding a proposal for **integration of e-Courts with Land Records database**. Additional Secretary (LR) participated in the National conference on **B-Ready Framework** organized by DPIIT on 13.02.2024.

6. As regards **National Generic Document Registration System** (NGDRS), State of Rajasthan started sharing data of registering property transaction documents with national portal of NGDRS (or e-registration) through API in the month of February, 2024. Thus, a total of 31 States /UTs have been onboarded under NGDRS.
7. Under **Vibrant Village Programme**, 66 border villages are to be mapped with respect to Watershed Management/Springshed activities. A VC meeting was held by the Department on 26th February 2024 with the State of Arunachal Pradesh on the progress under WDC-PMKSY project villages covered under the Programme.
8. A sensitization workshop on "**Safe disposal of e-waste**" was conducted on 13.02.2024 through VC for the employees of the Department. During the month, the Department organized two hands-on training programmes on "Implementation of e-billing" for employees.
9. Under **WDC-PMKSY 2.0 scheme**, Rs. 1289.34 Cr. against Rs. 1750.00 Cr.(RE) has been released during the financial year (2023-24).
10. Under **DILRMP scheme**, Rs. 107.33 Cr. against Rs. 125.00 Cr. (RE) has been released during the financial year (2023-24). The current status of progress (cumulative) of the different components of DILRMP scheme is as follows: -
 - i. Computerization of Land Records - Completed in 6.24 lakh villages out of 6.56 lakh villages (95%).
 - ii. Computerization of Registration - Completed in 5,061 SROs out of total 5,326 SROs (95%).
 - iii. Digitization of Maps – 2.52 crore Cadastral Maps/ FMBs /Tippans digitized out of total 3.02crore Cadastral Maps/ FMBs /Tippans (83%).
 - iv. Integration of Revenue and Registration - Completed in 4,670 SROs out of total 5,326 SROs (88%).
