Monthly Summary of important activities of Department of Land Resources during January, 2024

1. Secretary (LR) visited Madhya Pradesh from 12-14 January, 2024 to participate in the **Viksit Bharat Sankalp Yatra** in Sohaya village in Bhopal on 13th January, 2024. Abhinandan Patras were distributed to field functionaries for achieving saturation (>99%) in six core components of Digital India Land Records Modernisation Program (**DILRMP**) during the meeting. Further, progress of activities under DILRMP, auto mutation process and other best practices being taken up in Madhya Pradesh were reviewed. The Secretary also visited Cyber Tehsil, Bhopal to see the faceless e-mutation process. The Secretary also visited **Cactus experimental plots** at ICARDA, Amroha in Bhopal on 14th January, 2024 and reviewed the progress of ongoing cactus field trials and experiments and advancements made in biogas production under Watershed Development Component of Pradhan Mantri Krishi Sinchayee Yojana (**WDC-PMKSY**).
2. DoLR participated in the **National Conference of State Agriculture Secretaries and Revenue Secretaries on Digital Public Infrastructure** held in New Delhi on 5th January, 2024, where the usefulness of Bhuaadhar or ULPIN (Unique Land Parcel Identification Number) and other initiatives of the DoLR were highlighted for **Agri Stack**.
3. As of now, 29 States / UTs have rolled out **ULPIN**. Pilot testing is being carried out in four States / UTs, namely, Telangana, Manipur, Puducherry and Andaman & Nicobar Islands. Secretary has written D.O letters to all States / UTs for adoption/ expansion of ULPIN generation and for achieving saturation.
4. As regards **National Generic Document Registration System (NGDRS)**, State of Delhi has fully implemented eRegistration of deeds and documents.
5. A review meeting was taken by the Secretary with CEOs of State Level Nodal Agencies (SLNAs) of all States/UTs on WDC-PMKSY through VC on 11th January, 2024 to expedite works and utilisation of Scheme funds.
6. JS (LR) made a presentation on DILRMP in the 'Advanced Leadership Development Programme on Public Policy and Governance for Civil Servants of African Countries' on 23rd January, 2024 (virtually), organised by National Centre for Good Governance (NCGG).
7. JS(WM) along with team members participated in the **National Consultation Meeting of World Bank assisted REWARD programme** on 30th January 2024 for stakeholder consultation of the draft Technical Assessment Report prepared by National Rainfed Area Authority (NRAA) and its consortium partners.
8. Under WDC-PMKSY 2.0 scheme, Rs. 1130.73 Cr. (including Rs. 101.59 Cr. in January, 2024) against Rs. 1750.00 Cr. (Revised Estimate) has been released during the financial year (2023-24). Under the WDC-PMKSY 1.0 scheme, **6376** projects (99.91%) have been completed till date out of the total 6382 projects {8214 (Sanctioned) - 1832 (Transferred to State)}. End line evaluation of 6120 projects has been completed till now.

9. Under DILRMP scheme, Rs. 93.35 Cr. against Rs. 125.00 Cr. (Revised Estimate) has been released during the financial year (2023-24). The current status of progress (cumulative) of the different components of DILRMP scheme is as follows: -

- a. Computerization of Land Records - Completed in 6.24 lakh villages out of 6.57 lakh villages (95%).
- b. Computerization of Registration - Completed in 5,061 SROs out of total 5,329 SROs (95%).
- c. Digitization of Maps – 2.53 crore Cadastral Maps/ FMBs /Tippans digitized out of total 3.71 crore Cadastral Maps/ FMBs /Tippans (68%).
- d. Integration of Revenue and Registration - Completed in 4,669 SROs out of total 5,329 SROs (88%).
- e. Establishment of Modern Record Rooms - Completed in 3,465 Tehsils out of total 7,090 Tehsils (49%).
