A monthly summary of the important activities conducted by the Department of Land Resources in April 2024.

- 1. Secretary (LR) reviewed progress of implementation of Digital India Land Records Programme (DILRMP) with nine States/UTs viz. Assam, Haryana, West Bengal, Bihar, Uttar Pradesh, Punjab, Odisha, Himachal Pradesh, Uttarakhand, Jammu & Kashmir and Sikkim during the month through separate VC meetings. State/UTs represented by Additional Chief Secretaries and Principal Secretaries (Revenue/Survey and Settlement) made presentations on land registration activities in these States. Secretary (LR) also took review meeting with States of Andhra Pradesh, Rajasthan, Sikkim, Telangana and Uttarakhand on pilot roll out of National Generic Document Registration System /e-registration on 5th April 2024.
- 2. A meeting was held by Secretary (LR) to discuss about the proposed registry of government land on PM Gati Shakti Portal on 19th April 2024. The meeting was attended by officers from DPIIT, Bhaskaracharya National Institute for Space Applications and Geo-informatics (BISAG-N) and Principal Secretary (Revenue), Madhya Pradesh. Secretary (LR) held meeting with Director General, Directorate General of Defence Estates on the Defence Estates Management System developed by Defence Ministry. The Department held meetings with BIS representatives, Open Geospatial Consortium (OGC) representatives and experts to discuss land administration domain model (LADM) on 19.04.2024.
- Department of Land Resources participated in the various SGoS-1 (Agriculture and Rural) meetings held by Department of Agriculture and Farmers Welfare and finalized 100 Days and 5 Year Vision Action Plans at the Department level.
- 4. The third meeting of National Level Steering Committee (NLSC) on World Bank-assisted REWARD programme was held under the chairmanship of Secretary (LR) on 12th April 2024. The meeting reviewed progress achieved under REWARD scheme and finalized plan of action for next six months. The Department held review meeting with states/UTs for review of progress/expenditure under WDC-PMKSY 2.0 and other issues.
- Secretary (LR) held meetings with various Departments such as Department of Rural Development and Department of Animal Husbandry and Fisheries to ensure effective convergence of watershed development projects under WDC-PMKSY 2.0 with flagship schemes implemented by them.
- 6. The Department held meetings with SLNAs /CEOs of 10 States and representatives of ICAR institutions (CAZRI, ICFRI & CIAH) and ICARDA to discuss action plan to undertake pilot project for the Spineless Cactus cultivation under WDC-PMKSY on 2nd April 2024. Secretary (LR) held another review meeting on the proposed pilot Cactus project in Jaipur with SLNA, Rajasthan on 3rd April 2024. Subsequently, meeting on Cactus cultivation and its economic usages was held with ICAR, ICARDA, States of Karnataka and Odisha on formulating action plan for undertaking pilot cactus project.
- 7. Secretary (LR) undertook a field visit to Belgaum in Karnataka on 30th April 2024 and reviewed progress of watershed projects taken up under WDC-PMKSY.
