Monthly Summary of the important activities conducted by the Department of Land Resources in May 2024.

- Secretary (LR) participated in the World Bank's Land Conference held at Washington DC from 13th to 17th May, 2024. The Conference discussed the various innovative practices across countries on land management and administration.
- 2. The Department held a review meeting with States/UTs on 21st May, 2024 on Digital India Land Records Modernization (DILRMP) including Action Plan for 2024-25 and 2025-26 and progress of expenditure. The meeting was attended by Principal Secretaries and functionaries of State Governments and UTs. A meeting was convened by the Department on 29th May, 2024 to review implementation of National Generic Document Registration System (NGDRS) and its adoption by all States/UTs.
- 3. The Department signed a Memorandum of Understanding (MoU) with Vidhi Centre for Legal Policy on 9th May, 2024 for review and suggesting amendments in Registration Act, 1908.
- 4. For ensuring effective convergence of WDC-PMKSY 2.0 with DAY-NRLM, Secretary(LR) held a meeting with senior officers of Department of Rural Development on 2nd May, 2024. As a follow up to this meeting, Department of Land Resources held a VC meeting with States/UTs on 15th May, 2024 to understand scope of convergence activities in States under MGNREGS. Department of Land Resources held Regional Review Meetings with States/UTs through VC on 16th and 17th May, 2024 on implementation of livelihood component under WDC-PMKSY 2.0.
- 5. The Department held a meeting on 16th May, 2024 on Mid Term Evaluation of WDC-PMKSY through VC. Another meeting was held with the World Bank team, REWARD States, NRAA and its consortium partners on 16th May 2024. Secretary (LR) held a review meeting with representatives of ICIMOD on 22nd May, 2024 regarding various activities under Springshed Management.
- The Department held a meeting through VC on 30th May, 2024 on promotion of spineless cactus cultivation in Maharashtra and exploring the possibility of establishing of CBG/Green Hydrogen Plant for cactus biomass.
- The Department held a meeting with three States and prominent Government institutes working in the Watershed sector through VC on 31st May, 2024. The meeting discussed the framework for model watersheds under WDC-PMKSY.
