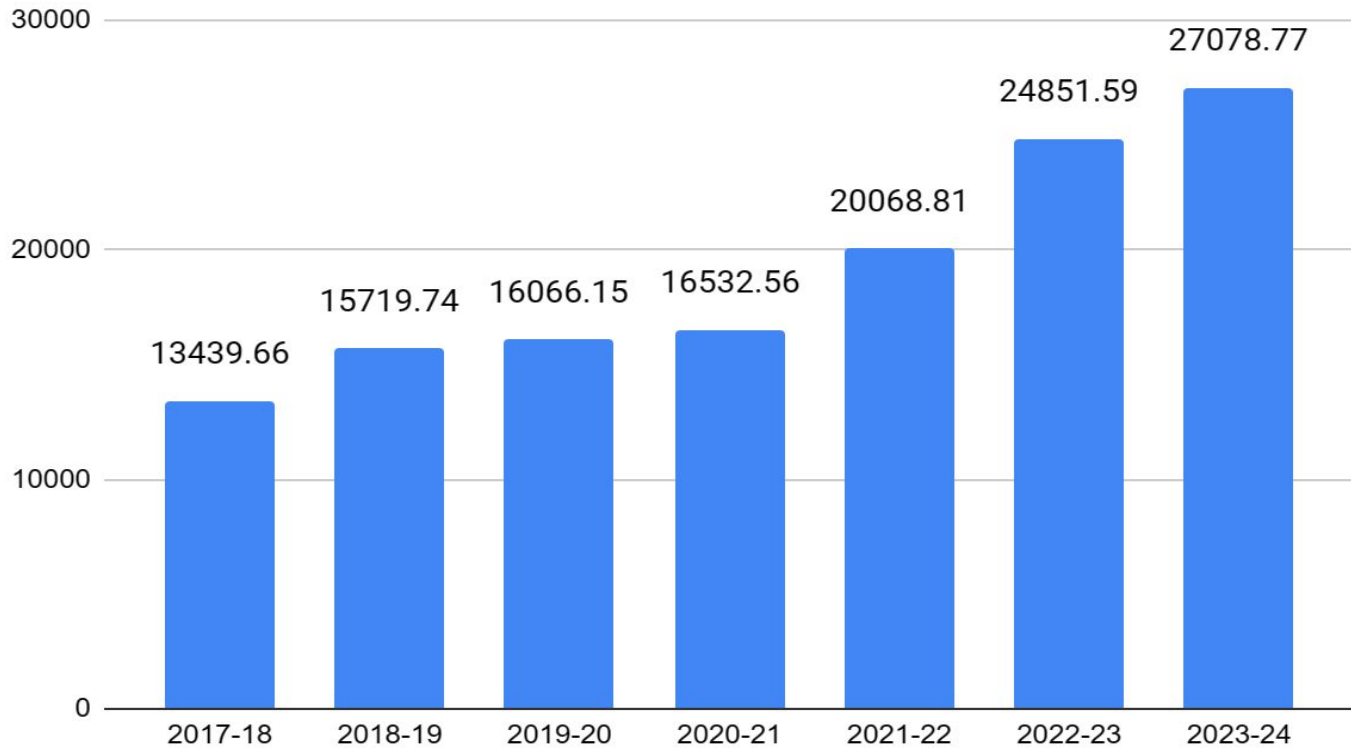
# Stamp and Registration Department Uttar Pradesh :- An Overview

- Stamp and Registration Department is an important source of revenue collection for the State Government .
- We are the third largest contributor for the state exchequer after GST and Excise.
- Total 379 Sub Registrar Offices (SRO) are working in the 75 districts of 18 divisions .
- In F.Y. 2023-24, Department has collected revenue of Rs.27078.77 crores
- Approx 2 crore people visit SRO annually.
- Approx 40 lacs and 62 types of documents are getting registered annually.

# Stamp and Registration Department Uttar Pradesh :- Source of Revenue and Collection System

- Non-Judicial Stamp Duty is the major Source of Revenue
- Collection of Stamp Duty through e-Stamping System is the most preferred way of stamp Duty payment (CRA- Stock Holding Corporation)
- More than 10,000 point of Sales for e-Stamping covering all the Subdivisions of the State.
- Saving the livelihood of Stamp Vendors by bringing them under the ambit of point of Sales for Stamp Duty payment through e-Stamping.
- Skill Development of Stamp Vendors through computer learning .
- E-stamping Contributes almost 99% of the total Stamp Duty Collection.



# Stamp and Registration Department Uttar Pradesh :- Contribution to Economic Growth of the State

- Collection through e-Stamp grew @10% annually in last 4 years.
- Issuing more than 1.30 Lac E-Stamps certificates a day.
- e-stamping system is fully integrated with the departmental portal, providing seamless validation and document registration.
- e-stamping System is also integrated with State Treasury for providing statistics of the receipts and seamless refund due to cancellation .
- Uttar pradesh is among the first State to provide digital e-Stamping to facilitate digital document execution in loan documents/ bank guarantee.

# Introducing E- Registration

## Uttar Pradesh Online Registration of Document Rules, 2024

To be allowed for specified entities (development and Industrial development authorities) for sale, agreement & lease deeds.

- Presentation and acceptance to be done in front of designated nodal officers of the respective entity.
- Photograph & signature of the parties to be taken digitally.
- Registration to be done by SR on the basis of electronically transmitted data.
- Provision for background impression to prevent fraud.
- Provision of Thumbnail print to reduce cost.
