Rajasthan has taken few citizen centric initiatives to ease out the services being rendered to the citizen by Registration and Stamp Department



Citizen can select DLC for the property based on the Geo-Coordinates. Selection the property would result into the DLC based on the selected property type.

Site Inspector App

For property evaluation by SR / Girdawar Site inspector app can be used to inspect the site to verify the information filled by citizen. and fill the mandatory information.



Stamp Vendor Mobile app is developed for stamp vendor and DIG offices to maintain and monitor the sale of stamps. Stamp vendor sales the stamp via this app and details of the purchaser can also be capture via this ap.

Model SR office

10 districts have been chosen for Model SR offices. These Offices provide citizen centric facilities for deed registration. 9 Offices are at present working Jodhpur, Bikaner, Bhiwari, Kota, Bhilwara, Ajmer, Jaipur SR-II, Jaipur SR-, Bharatpur. Work for Udaipur is in development.








