- Omission of survey numbers, wrong entry of survey numbers, wrong joins.
- Wrong version of map digitized.
- Wet map not digitized, if digitized also not integrated seamlessly.
- > Errors of georeferencing. Only one point (village site) taken as control point for geo-referencing.
- Edge Matching of village boundaries not proper, particularly some area in a village is truncated with out verifying ground.
