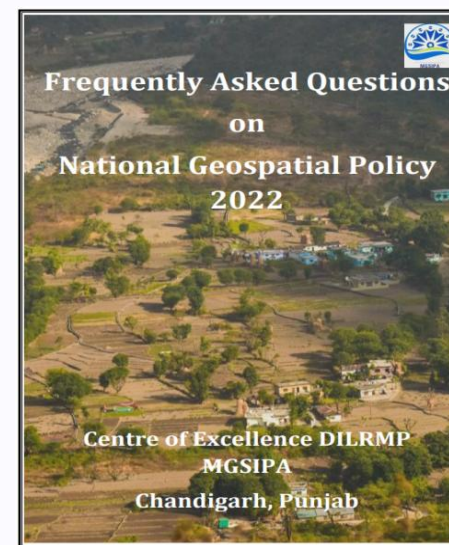

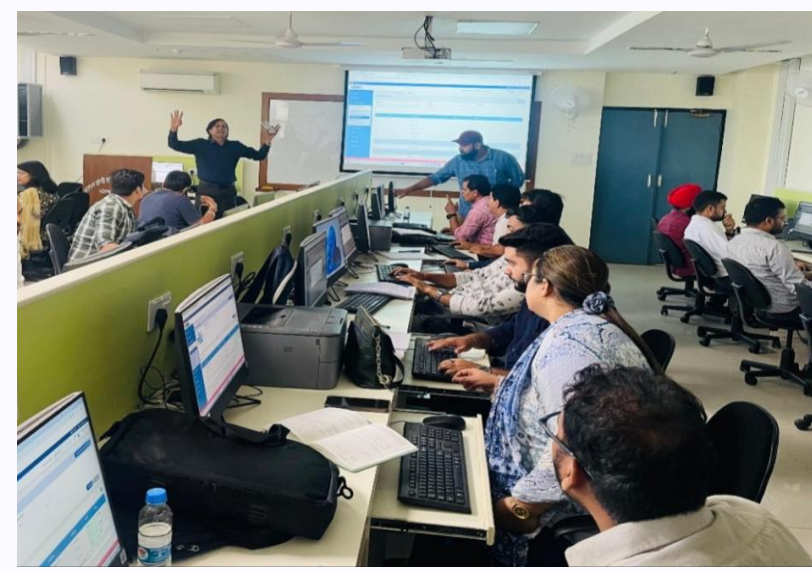
## Phase II
