Sir,

The undersigned is directed to refer to letter No. 21014/04/2024-LRD-Part (1) on the subject mentioned above and to convey the approval of the Competent Authority towards release an amount **₹23,80,411/- (Rupees Twenty-Three Lakh Eighty Thousand Four Hundred Eleven only)** i.e. [Rs. 15,43,070/- for DILRMP NPMU members and Rs. 8,37,341/- for NAKSHA NPMU members'] towards the salaries for the month of August and September to National Institute of Urban Affairs (NIUA), New Delhi.

2. The approval of the grant is subject to the following terms and conditions.

- i. The release shall be restricted to the actual admissible expenditure towards salary/remuneration for August and September 2026, duly supported by requisite documents and subject to adjustment of the unspent/excess amounts indicated above.
- ii. The Utilization Certificate (UC) and Expenditure Statement head -wise shall be furnished by the NIUA, New Delhi to this office in the prescribed format (GFR 12-A), duly signed and stamped by the Head of the Organization and Chief Finance Officer as per GFR.
- iii. The funds presently released are only to be utilized for the purpose for which it was sanction.
- iv. All relevant conditions of General Financial Rules, 2017, as amended from time to time will be applicable to the grantee organization.

3. The aforesaid release of **₹23,80,411/- (Rupees Twenty-Three Lakh Eighty Thousand Four Hundred Eleven only)** will be met from the sanctioned budget grant for the year 2026-27 under Demand No. 88 – Department of Land Resources as per the details given below:
