2. The approval of the grant is subject to the following terms and conditions:

- I. Time is the essence of this Programme, so it is expected that the State will adhere to the timelines given for the NAKSHA components.
 - II. The State Government must follow the prescribed procedure for purchase of the approved items.
 - III. Fund shall be utilized for the purpose for which it has been sanctioned. No diversion of funds is permissible.
 - IV. The State Government shall submit item-wise expenditure and physical progress and utilization certificate separately for NAKSHA in the prescribed proforma in respect of the funds released under the scheme.
 - V. The State Government should ensure that expenditure is incurred only on approved activities as per the guidelines and circulars issued from DoLR from time to time.
3. All the activities sanctioned under the programme shall be completed by the State Government within the financial year 2026-27.
4. The aforesaid release of **₹3,69,15,775/-** will be met from the sanctioned budget grant for the year 2026-27 under Demand No. 88 - Department of Land Resources as per the details given below:

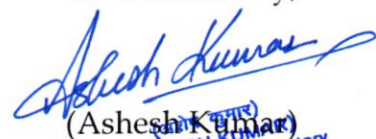
