 - execution of the prescribed contractual agreements &
 - obtain the joining reports of the selected candidates.
5. The waitlisted candidates shall remain valid only for the purpose of filling any vacancy arising due to non-joining, resignation, or termination of the selected candidate, subject to approval of MASLSA.
6. The selected candidates are hereby directed to report to the concerned Secretary, DLSA on **27th July, 2026**.
