Subject:- Instructions regarding 'Policy for purchase of land voluntarily offered to Government for development projects'.

On the subject cited above a meeting of Web Portal (www.ebhoomiharyana.org.in) has been held on 04.12.2018 under the Chairpersonship of Hon'ble Chief Minister, Haryana wherein the following decisions were taken:-

- i) The indenting department should be able to decrypt the price immediately after last date for submission of land sale offers is over. Further, the concerned Deputy Commissioner should also be able to view the price.
- ii) An intimation of the land requirement of the department should invariably be sent to the Public representatives of the concerned area.
- iii) The indenting department, in association with the concerned District Authorities shall carry out the verification of the land sale offers and the initial scrutiny shall be completed preferably within a month of receipt of matching land sale offers. The land sale offers should be displayed by way of GIS on the e-bhoomi portal using Google map with digitized data from HARSAC, with a view to assess contiguity of land offered for sale.
- iv) A provision shall be made on the e-bhoomi portal to record the details/decision of meetings of Committee of Secretaries and High Level Land Purchase Committee by the indenting department in respect of their land requirement.

You are, therefore, requested to take immediate necessary action in the cases of land purchase under 'Policy for purchase of land voluntarily offered to Government for development projects' as per above decisions. These instructions may be brought to the notice of all concerned for strict compliance.
