The Governor of Haryana is pleased to constitute the Shivalik Development Board and its Associate Agencies to be known as Co-ordination Committee and District Implementation Committee for the overall integrated development of the hilly and semi hilly area comprising Morni, Pinjore, Barwala, Raipur Rani and Naraingarh blocks of District Ambala, Chhachhrauli, Sadaura and Bilaspur blocks of district Yamuna Nagar. The integrated development will be of agriculture, floriculture, herbal plantation, education, Public Health, buildings and roads, irrigation, water supply, management, banking, tourism, forest, poultry, animal husbandry and wild life etc..

(e) It will review the progress of schemes under the other ongoing programmes to dovetail them with special schemes taken up under the additional allocation of funds made by the State Government.

(b) Suitable funds will be placed at the disposal of this agency to enable it to implement these schemes. Additional funds over and above the budgetary allocation of different departments will be provided for implementing area-based and beneficiaries-based schemes formulated by the agency for the development of the region.

(c) The Chief Executive Officer, Shivalik Development Board will be its Principal Officer for implementing the schemes at the field level. He will work under the overall supervision and control of the Chairman of District Implementation Committee and co-ordinate the implementation of the schemes of different departments.

(d) Block Development and Panchayat Officers would be responsible for implementing the schemes in the areas under the overall supervision and control of the agency.

2. The official members of the Board, the Co-ordination Committee and District Implementation Committee will draw their travelling allowance from their respective Departments. The non-official members shall be entitled to travelling allowances for attending the meeting of the Board/Committee in accordance with the instructions issued by Haryana Government from time to time. The Travelling Allowance to non official members will be paid by District Implementation Committee from the grants placed at its disposal.
