2. In this regard it is submitted that Sh. Manmohan singh who has been shown at Sr. No. 05 has been ordered to be transferred from Tehsil, Punhana to Bawal against vacant post within one year of his superannuation i.e 30.11.2021. As such in view of the provisions made in the standing instructions, he cannot be transferred from Tehsil, Punhana to Bawal against vacant post unless and until his consent for the said transfer is received. However, consent of Sh. Manmohan Singh, Tehsildar has been received for transferring him from Tehsil, Punhana to some other Tehsil even though he is retiring within one year of his superannuation.

3. It is further submitted that following transfers orders are not being issued due to technical issues on HRMS Portal:-

- i. Manoj Kumar, Tehsildar, Jind to Sonipat (Against Vacancy)
- ii. Ajay Kumar, Charkhi Dadri to Jind (Vice Manoj Kumar)
- iii. Jodha Ram, Nilokheri to Loharu (Against Vacancy)
- iv. Suresh Kumar, Narnaund to Radaur (Against Vacancy)

As such the aforesaid Tehsildars will be awaiting posting and their posting orders will be issued after resolving the technical issues.

3. As a result of foregoing discussion, if agreed, the transfer orders received from the Hon'ble CM/Deputy CM may be issued since they are not being ordered to be transferred in their home district nor retiring within one year of their superannuation.

Accordingly, case along with draft is submitted for consideration/approval/orders.
