The Committee will ensure to formulate an objective criterion to decide these cases, will decide the requests on first-come first-serve basis and will also devise a prompt mechanism for entertaining the requests through WhatsApp or e-mail and ensure decision on urgent basis. Dr. V.K.Bansal, ADGHS (8558897640) will coordinate with the Committee.

The request from health institutions through the Director/MS/Head of ICU of respective health facility for allocating the drug shall be submitted to the Chairman of the Committee with copy to members, along with the details as required by the Committee.

The drug would be stocked at the warehouses of the department, as follows:

The supply to private institutions would be on the actual cost, as procured and informed by HMSCL. The amount shall be reimbursed and deposited in SKS account of concerned Civil Surgeon. However, for all Government institutions (Medical Colleges & Hospitals) it would be provided free of cost. The drug would be indented by Civil Surgeon and issued to concerned health facility after approval of Committee.
