Subject: Actions to curb air pollution in the districts around the National Capital Territory Delhi i.e. Gurugram, Faridabad, Sonipat and Jhajjar.

With an aim to curb the air pollution in the districts around the National Capital Territory Delhi, i.e., Gurugram, Faridabad, Sonipat and Jhajjar, while exercising the powers conferred under Section 24 of the Disaster Management Act, 2005, the undersigned in his capacity as Chairperson, State Executive Committee, hereby orders the following directions for strict implementation in these above mentioned four districts of the State:-

- 1 All Government and Private Schools shall close.
- 2. With an aim to reduce 30% plying of vehicles on roads which will impact vehicular emissions and also reduce dust in the air, all Government and private offices are advised to do work from home. Vehicles older than 10/15 years (Diesel/Petrol respectively) shall be strictly checked with regard to emissions and impounded accordingly.
- 3. There shall be complete ban on all type of construction and development activities. Mechanised Stone Crushers and Hot Mix plants used in construction activities shall be closed.
- 4. No trash burning by Municipal bodies shall be allowed.
- 5. Stubble burning shall be prohibited.
- 6. No manual sweeping of roads shall be allowed. To control dust pollution, water sprinkling on roads shall be done.
- 7. Deputy Commissioners shall constitute joint inspection teams for enforcing the above directions/instructions and shall ensure extensive checking, monitoring and action against the violators as per



law/rules/instructions/directions issued from time to time by the Government of Haryana

8. These guidelines will come into force with immediate effect and remain operational till 17 November 2021. The district administration shall ensure wide publicity by MUNADI (beat of drums) within their jurisdiction. Publicity shall also be carried out through press release and social media.

Strict compliance of the same directions be ensured by all concerned.
