- 2. The applicants will have to appear for an interview.
- Only shortlisted candidates shall be called for the interview at the venue, date and time as decided and directed by the Department.
- 4. Applicants have to bear their travel cost and no TA/DA shall be paid for the purpose.
- 5. Candidates not having requisite essential qualifications and experiences as mentioned with the posts are liable to be summarily rejected. Candidates will have to produce the proof of details furnished in their applications, in original as and when required.
