Shri V.S. Kundu, IAS (Retd.) is hereby appointed as Chairman of one man Revenue Commission. The main terms and assignments of the Commission will be as under :-

• Land Records

- Define easily understood terminology and replacement of Persian/Urdu terminology with this terminology.
- Recasting of Land Records format to include PPP/Aadhar (as the case may be) and to consider including other data related to land uses as part of land records such as court cases, development rights etc.
- Recommend cumulation and management of Government lands and Panchayat/ PRI/ Municipal lands in land records.
- Define methodology for arriving at Collector Rates based on fair market value land-segment or land-parcel wise.
- Define processes, methodology and requirements for land measurement using technology (CORS and rovers) and upgradation of land maps.
- Define processes and mechanisms for Consolidation of lands using GIS-based technological process.
- Define processes and mechanisms for a robust and efficient property transaction registration system.
- Define new training systems for field officials in the modern technology context.
- Drafting or redrafting of land laws in the modern context.
- Define roles and responsibilities of various revenue administration officials in the modern context.

The terms and conditions of appointment of Shri V.S. Kundu, IAS (Retd.) as Chairman of one man Revenue Commission will be issued later on.
