The 9th February, 1996

No. G. S. R. 14/Const./Art.309/96.—In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and all other powers enabling him in this behalf, the Governor of Haryana hereby makes the following rules further to amend the Haryana Revenue Department District Subordinate (Group C) Service Rules, 1988, namely:—

1. These rules may be called the Haryana Revenue Department District Subordinate (Group C) Service (Amendment) Rules, 1996.

2. In the Haryana Revenue Department District Subordinate (Group C) Service Rules, 1988 (hereinafter called the said rules), in rule 9, after clause (j), the following clause shall be inserted, namely:—

“(k) in the case of Driver:—

(i) 80% by direct recruitment; and

(ii) 20% by promotion from amongst Group C or Group D employees having scales less than those of Drivers; or

(iii) by transfer or deputation of any official already in the service of any State Government or the Government of India.”

3. In the said rules in Appendix A, after serial number 10 and entries thereagainst, the following serial number and entries thereagainst shall be added at the end, namely:—

“11. Driver 126 4 130 Rs. 1200—30—1560—
EB—40—2040—Rs. 100
as special pay.”

4. In the said rules, in Appendix B, under columns 1, 2, 3 and 4, after serial number 10 and entries thereagainst shall be added at the end, namely

“11. Driver (i) Middle Pass with Hindi; (i) Middle pass with Hindi;
(ii) Valid driving licence to drive light transport vehicles on all types of roads, alongwith (ii) Atleast five years experience as Group C or Group D employee.

given to the person
having higher quali-
fications/knowledge in
motor mechanism or
who will be having
genuine experience of
car repair.

(ii) Valid driving licence to
drive light vehicles on
all types of roads,
alongwith two years
experience of driving
light motor vehicles in

Government/Boards/
Corporation etc.

Preference will be
given to those posses-
sing higher qualifications
and knowledge of
motor mechanism and
who will be able to exe-
cute minor repairs."

5, 6 and 7, after serial number 10 and entries thereagainst, the
following serial number and entries thereagainst shall be added at the
end, namely :—

"11. Driver	Deputy Penalties Commis- (i) to (x) sioner above	Deputy Commis- sioner	Financial Commis- sioner (Revenue)".

2. In the Haryana Revenue Department District Subordinate (Group C) Service Rules, 1988, in Appendix B, against serial number 11, under columns 3 and 4 for the words "light vehicle" wherever occurring, the words "light transport vehicle" shall be substituted.
