





Registered Vehicle Scrapping Facility (RVSF)

In the past, there was no established legal procedure for scrapping old and unfit vehicles. As a result, vehicle owners would either visit unauthorized scrapyards or abandon their old, polluting vehicles in dump yards or at public places. Both scenarios presented security issues and contributed to environmental pollution. In an effort to phase out such vehicles, the Ministry of Road Transport & Highways (MoRTH) introduced the Motor Vehicles (Registration and Functions of Vehicle Scrapping Facility GSR 653(E)) Rules in 2021.

Registered Vehicle Scrapping Facility (RVSF) application, as per GSR 653(E), enables motor vehicle owners to easily phase out old and unfit vehicles that have high emissions and deteriorate air quality. The primary objective of this application is to remove polluting vehicles from running on the roads and subsequently lower the country's carbon footprint. All applications and processes for vehicle scrapping have been made online and time-bound for vehicles registered on the Vahan portal. This initiative marks a significant step towards a greener environment and aims to create a circular economy that generates value for every stakeholder involved. This is also part of the government's Voluntary Vehicle Fleet Modernization Program, which envisages replacement of old polluting vehicles with new, fuel-efficient and low-polluting alternatives. The application also encourages the setting up of inspection and fitness centres and scrap yards to assess the condition of vehicles before scrapping them.



- Complete Integration with National Single Window System (NSWS).
- RVSF is registered automatically as and when approved in NSWS.

 - 25 % rebate on MV tax for Non-Transport vehicle
 - Full waiver of Registration fee on purchase of a new vehicle
 - Trade CD on NCDEX trading platform.
- Checking pollution by scrapping vehicles that do not pass the fitness test.
- >> Scrapping of unfit/old vehicles is done in an environmental friendly manner.
- >> Scrapping Centres are now organised, transparent and environment friendly and also, under the control of government.
