Instructions for Shortlisted Candidates

1. The candidates shortlisted for **Stage-II: Driving Proficiency Test and Document Verification** are required to report at **HRTC Divisional Workshop, Taradevi, Shimla, on 04.07.2026 (Saturday) at 09:30 A.M.** positively. The Driving Proficiency Test shall commence from **10:00 A.M. onwards.**
2. All shortlisted candidates shall bring the **original certificates/documents/testimonials** in support of the information furnished in their online application form, including the documents submitted during the one-time opportunity provided for removal of deficiencies/discrepancies, along with one set of self-attested photocopies of the same.
3. The candidature of the shortlisted candidates is **purely provisional**, subject to verification of the original documents and fulfillment of all the eligibility conditions prescribed in the Advertisement Notice.
4. If any discrepancy, variation, concealment, false information or mismatch is found between the original documents and the documents/information submitted online or during the one-time opportunity, the candidature of the concerned candidate shall be liable to be rejected forthwith.
5. No request for change of date, time or venue of the Driving Proficiency Test or Document Verification shall be entertained under any circumstances.
6. No separate call letter shall be issued. The publication of list of the shortlisted candidates on the official website of the H.P. State Legal Services Authority, along with the communication sent through

email/SMS, shall be treated as sufficient intimation to the shortlisted candidates.

7. No Travelling Allowance (TA), Daily Allowance (DA) or any other expenses shall be admissible for appearing in the Driving Proficiency Test and Document Verification.
8. The decision of the Committee regarding eligibility, document verification and conduct of the Driving Proficiency Test shall be final and binding.
