


MPRRDA(M.P. Rural Road Development Authority) is appointed as a nodal agency for connecting habitations/ villages which does not cover under the PMGSY scheme. These habitations will also be connected through Road network under MMGSY scheme of State Government of MP.</p> <p>GeoReach is an e-Governance solution being developed for monitoring the workflow of Rural road connectivity project. GIS part of application strengthens user to take better decision for creation of infrastructure. It also helps in maintaining inventory of rural roads. The application covers management, technical and financial aspects of the project. It aids and assists the MPRRDA officials, World Bank, Civil Contractors, Banks, SQM and general public. It is a G2B, G2G &amp; G2C enterprise solution which has an access via internet <a href="https://gismp.nic.in/georeach">https://gismp.nic.in/georeach</a> available in public domain. It's a fusion of new &amp; emerging technologies like Cryptography (Digital Signature &amp; SSL), GIS &amp; Remote Sensing, Mobile, Open Web technology, SMTP &amp; SMS.</p> <p>It provides interface for public to participate in the monitoring of road maintenance. Citizen can upload Geotagged photographs to raise their grievances on the condition of the road. The efforts have been made for integrating PFMS in GeoReach application.</p>		<p>GeoReach is successfully running on the web and is extensively being used by MPRRDA. <b>2. APMS (Access Permission Management System) (<a href="https://apmsmp.nic.in">https://apmsmp.nic.in</a>)</b>		
<b>Description of the Project</b> <p>MPRDC has been notified as State Highway Authority as per Section 4 of the MP State Highway Act 2004 by the State Government. Section 5 of the Act 2004 authorizes MPRDC for the restriction or regulation of use of land appurtenant to Highways and Section 12 of the Act 2004 notification for Building lines and control lines. Any infrastructure that comes up or certain activities on MPRDC roads requires due permission from MPRDC. Site where the permission is sought is inspected by MPRDC field officers. Permission is sought for Retail outlets (Petrol Pumps, Restaurants etc.), cable laying/ pipeline, Overbridge, Oversized vehicle etc.</p> <p>Access Permission Management System (APMS) is an online application used for automation of process for restriction/ regulation of use of land appurtenant by the beneficiaries/ owner. APMS handles the work flow, online submission/ track and makes process transparent. ### Less Dense and Dynamic QR Codes

QR, or Quick Response, codes deliver immense value as their ease of use and as they are a no-contact medium for exchanging information. With the ability to scan a code just by pointing your phone's camera at it, QR codes are a great addition to informational material, point of purchase (POP) material, and more.

A static QR code contains information that cannot be changed. Once the QR is created the destination URL cannot be altered. A dynamic QR code can be edited by the creator, even after they've been created. The dynamic QR code could be linked to a new destination URL.

## 26. e-Granthalaya

### Description of the Project:

### 2. Name of the Project : Digitalization of Mantralaya Records (GAD)

#### Description of the Project:

As a part of AtmaNirbhar MP initiative, scanning agency was hired by GAD to OCRize old Mantralaya Records/files(about 2.5 crore pages) housed in govt. record room since 1950's. For seamless storage/retrieval, referencing and searching within scanned documents, GAD decided to use KMS Module(Document Management System) of eOffice suite.

As instructed by GAD, a web application was also designed and developed by NIC for online monitoring of the entire digitization process, which is still going on and is likely to continue till Sep, 2025.

Based on the KMS reports, uploaded pagecount for each month is calculated and shared with GAD for release of payment to the scanning agency/vendor.

#### Status of the Project

Partially implemented.

About 2,61,965 files from 33 Mantralaya Departments have been uploaded to KMS till now.

### 3. Name of the Project : Pratibimb Mobile App (IOS Version)

#### Description of the Project:

Pratibimb is a NIC-developed mobile application designed for document scanning and management.
