The Governor of Haryana hereby orders that the notification no. 13/6/2018-3SYA dated 7th September, 2018 governing cash awards to sportspersons will be effective from 1st April, 2017.

However, Para **"VII. Incentive to Coach(es)"** in the said notification will be effective for tournaments commencing on or after 7th September, 2018.

2. Junior and sub-junior category tournaments were not eligible for cash awards prior to the notification dated 7th September, 2018. The Governor of Haryana is pleased to order that cash awards will also be given in the following junior and sub-junior category tournaments played during the financial year 2016-17.

3. It is hereby clarified that the word, "sports disciplines" appearing in Para **"II. RESTRICTION ON SPORTS DISCIPLINES ELIGIBLE FOR CASH AWARDS"** of the notification dated 07.09.2018 shall be construed as "sports events". For the purpose of Para II of the notification, ibid, cash awards during the years 2017-18 and 2018-19 will be restricted as follows:-

- A. In the case of World Cup/Championship, World University Games/ Championship, Asian Cup/ Championship, Commonwealth Cup/ Championship, SAF Games, National Championship and All India Inter-University Tournaments/ Championship:-
- (i) Sports events included in Olympic Games-2020 or Asian Games-2018 or Commonwealth Games-2018.
- (ii) Chess.
- B. In the case of Para World Games/Championship and Para National Championship:-
- (i) Sports events included in Paralympic Games-2020 or Asian Para Games-2018 or Commonwealth Games (Para-Sports)-2018.
- (ii) Chess.

4. Attention is drawn to Para "**IX. General Conditions**" of the notification dated 07.09.2018 for strict compliance. Cash awards will not be given to sportspersons in following cases:-

- i) Sportspersons who made wrong claims earlier on the basis of false information or concealment of material information. In case any such proceeding is pending against a sportsperson, the cash award will be withheld till finalization of the pending proceeding.
- ii) In the case of any sports related misconduct.
