TERMS & CONDITIONS

a)Tenure

The contractual engagement will be for a period of **one year**, subject to satisfactory performance, periodic reviews, and result-oriented assessment, and shall at all times be coterminous with the Khelo India Scheme.

b) Tax Deduction at Source

Income Tax or any other tax liable to be deducted, as per prevailing rules, will be deducted at source before effecting the payment. This department will issue TDS/Service Tax Certificates, as applicable.

c) Other Allowances

No TA/DA shall be admissible for joining the assignment or on its completion. No other facilities such as DA, accommodation, residential phone, conveyance/transport, personal staff, medical reimbursement, HRA, or LTC, etc. shall be admissible.

d)Extension

The performance of the selected candidates will be continuously reviewed, and their extension will be considered on the basis of periodic review/requirement.

e)Leave

Selected candidates will be entitled to 30 days of leave in a calendar year on a pro-rata basis. Beyond this, no remuneration shall be admissible for absence. Unavailed leave in a calendar year shall lapse and will not be carried forward.

CONFIDENTIALITY

- a)** Selected persons shall not publish a book, compilation of articles, participate in a broadcast, or contribute any article (anonymously or pseudonymously) using information gathered during this assignment.
- b)** During the period of engagement, the employee will be governed by the provisions of the Indian Official Secrets Act, 1923, and shall not divulge any information gathered during the engagement to any unauthorized person.
- c)** The selected personnel shall not, at any instance, represent or give opinion/advice to others in any matter adverse to the interest of the Government.

OTHER CONDITIONS
