2.- The seniority of the officials will be fixed in accordance with the percentage mentioned under Rules of Haryana Treasury Establishment Subordinate Group 'C' Service Rules, 1980 amended from time to time.

3. They will remain on probation for a period of one year and will be governed by the Haryana Treasury Establishment Subordinate Group C Service Rules, 1980.

4. They will be required to pass a type test at a speed of 25 w.p.m. in Hindi or at the speed of 30 w.p.m. in English within a period of one year of their joining as clerk:-

If they pass the type test before the prescribed one year, they will be given the increment which would have otherwise fallen due to them at the end of the prescribed period with effect from the last day on which the type test was

completed but the next increment will be due to him/them only on the date on which it would otherwise become due.

If they pass the type test after the prescribed period of one year, then the increment for the period subsequent to that within which the type test was to be passed shall be released to them in the retrospective effect from the date these were otherwise due from the date following the last day on which the type test was completed, but no arrear shall be paid for the past year.

5. If they fail to pass the departmental examination or any part thereof and is subsequently exempted by the competent authority for passing the type test their increment for the period subsequent to that within the type test was to be passed, shall be released with retrospective effect from the date these were otherwise due from the date, they will be given such exemption but, no arrears shall be paid for the past period.


