

ORDER

In compliance of Hon'ble Punjab & Haryana High Court orders dated 31/10/2017 in CWP No. 5662 of 2014- Jai Pal Kaushik & Others Vs State of Haryana and Government order No. 29/37/2014-5FA Dated 04-12-2018, the following petitioners are regularized on the post of Junior Programmer in the functional Pay Scale of 5000-7850 w.e.f. 01-10-2003 and further posted as follows:-

2. The above petitioners shall be granted all consequential benefits in terms of grant of higher standard/ACP scale/ pensinoary benefits etc, with arrears of emoluments to be given to them restricted to a period of 38 months prior to from the date of filing of the petition on 21.03.2014 as per order of Hon'ble Punjab and Haryana High Court in CWP No. 5662/2014 dated: 21.03.2014.

3. Sh. Vinod Kumar SO was regularized as DEO vide this Department order dated 15-6-2006 and was posted in Head Quarter against sanctioned post of Head Quarter. His inter-se seniority will be maintained as JP at Head Quarter. Since he has been selected in SAS Cadre vide order dated 18-6-2014 his seniority is now being maintained as Section Officer and hence only consequential benefits as per Hon'ble High Court order shall be released/extended to them.

4. Sh. Anil Kumar (SAS Part-1) will get consequential benefits as per order of Hon'ble High Court. In future, if he is reverted back to parent cadre he will be posted as Junior Programmer or equivalent post whichever is available at that time. His inter-se seniority will be maintained in the seniority list of Junior Programmers till his absorption in SAS cadre.

5. All the twelve petitioners would be deemed to be in active regular service with effect from 01.10.2003 to 15.06.2006, with that period to count towards their pension and other retirement benefits.

6. The above regularization is subject to condition that all petitioners will have to withdraw the CWP 9340 of 2017 which is admitted in the Hon'ble Punjab and Haryana High Court at Chandigarh within two months.

7. Seniority of the petitioners will be maintained as inter-se which is being maintained as on today.


