Subject:- Revision/Verification of Pension Cases in Online Diary Application System (ODAS) - To facilitate the Pensioner.

Please refer to the Finance Department's instruction dated 16.01.2018 and subsequent orders issued thereafter on the above mentioned subject. Vide these instructions it was desired that the amount of Pension/Family Pension should be verified by SAS personnel of the concerned Department before sending it to Principal Accountant General (A&E) office.

In the above backdrop, attention of the Government/Department is being drawn towards non availability of SAS personnel in the office of a particular DDO, due to which revised pension cases are being delayed. Pensioner Associations have also approached Government/ Principal Accountant General (A&E) Haryana to look into the matter.

It has been decided that SAS personnels available in a district, posted in different Department/Board/Corporation are authorised to verify pension revision cases of Education and Health Departments in the first go. A list of such SAS personnels is being annexed for compliance.

Hence, all concerned SAS personnels (as per annexure) are directed to verify the pension revision cases of their respective assigned district/offices in a time bound manner and as per instruction issued by Government in this regard from time to time so that hardship faces by a pensioner/DDO may be avoided. It is further directed to report the progress on fortnightly basis to the undersigned through e-mail.
