On the recommendation of Haryana Staff Selection Commission vide letter no. HSSC/Confd/Recomm/2018/613 date 28-07-2018, the following candidates are hereby posted in Treasury/Sub-Treasury in the State as under on the terms/conditions as mentioned below their appointment letter appointed provisionally on a temporary posts of Clerk in the Treasuries & Accounts Department Haryana (Field Offices) in the pay scale of Pay Matrix Level-2 (19900) (Pre-Revised pay scale PB1 5200-20200+1900GP) with usual allowances as are admissible under the Haryana Government instructions issued from time to time:-

- These appointments are against a purely temporary post, your services are liable to the terminated without assigning any reason by giving one month's notice or pay and allowances in lieu thereof, at any time. Further your appointment would be

subject to the outcome of the proceeding pending before the Hon'ble Supreme Court in the appeal following by the State of Gujarat on a similar issue as per Annexure 'A'.

2. If at any stage you desire to resign, you will be required to give one month's clear notice or deposit/forfeit in lieu thereof one month's salary including allowances or for the period by which the notice falls short of one month in case of your temporary appointment and in case of your permanent appointment, you will be required to give three months clear notice or deposit/forfeit in lieu thereof your three months salary including allowances for the period by which the notice falls short 3 months, such a notice will also be given to you by the competent authority in case it is proposed to terminate your service except as a result of disciplinary action for any other reasons.
3. No TA/DA will be admissible for joining the post.
4. Before assuming the charge of duty you will be required to take the prescribed oath of allegiance to the Constitution of India.
5. If they have not been vaccinated within the last 12 Months, they should have it done now immediately.
6. No application for employment outside the Department will be considered before they complete 2 Years service in the Department.
7. They will have to produce an Affidavit duly attested by the Oath Commissioner/Magistrate to the effect that they have not more than one living wife, if married.
8. They should submit Medical Fitness Certificate from the concerned Chief Medical Officers within one month of your duty as required under rule of Haryana Civil Services (General) Rules 2016 failing which this appointment shall stands cancelled.
9. They should have to pass State Eligibility Test in Computer Appreciation and Application (SETC) within the probation period as per Haryana Treasury Establishment Subordinate (Group C) Service (Amendment) Rules, 2013 failing which you will be terminated from service
10. They have to abide by such rules and regularization as may be issued by the Haryana Government governing the condition of its employees from time to time.
11. They will not undertake higher study of any kind without obtaining the prior permission of the competent authority.
12. They are required to submit an affidavit duly attested by the oath Commissioner/Magistrate to the effect that you have not been dismissed from any Government service, if any held by them previously.
13. Their appointment to these posts in the service is being made on probation for a period of two years. If your work and conduct is not found satisfactory, your services can be terminated without assigning any reason. The period of probation can be extended by the competent authority upto one year more.
14. Their seniority will be fixed in the cadre of Clerk, according to the merit list prepared by the HSSC and not on the basis of their joining on the post.
15. Their appointment is subject to the condition that their documents pertaining to their qualification, experience, age and caste/ category shall be got checked/

verified from the issuing authority and if something is found objectionable , they will not be eligible to continue in service.

16. They shall be governed under National Pension Scheme, 2006.
17. The above offer of the appointment is further subject to the Haryana Treasury Establishment Subordinate (Group C) Service (Amendment) Rules, 2013 as amended from time to time and all other rules and regulations and executive instructions issued or to be issue by the State Government from time to time.
18. As their character and antecedents have not been got verified in terms of instructions issued vide Memo No. 52/3/2005-6S (1) dated 18 Nov 2005 therefore, it is made clear to them that in case subsequently any adverse facts come to the notice of the State Government regarding their character and antecedents, their services will be liable to terminated without giving any notice.
19. These appointments are subject to the final outcome of CWP No. 14886, 16873, 19270, 23764, 23861, 23882, 23906, 24057, 24060, 24098, 24191, 24247, 24278, 24288, 24436, 24535, 27510 and 29740 of 2017 and 1252 of 2018 and any other writ petitions pending in the Hon'ble High Court.
20. These appointments an further subject to the outcome of the proceeding pending before the Hon'ble Supreme court in the appeal filed by the State of Gujarat on a similar issue.

If they are willing to accept this offer on the terms and conditions mentioned above they should report for training alongwith all the original documents in the office of Principal, Accounts Training Institute, Sec-5 Panchkula, on 07-08-2018 you will undergo training for 2 months at Panchkula. Candidates are required to make their own arrangement for boarding and lodging. During the period of training they will be entitled for pay and allowances as per rules. They are also informed that their training will be extended at the end of each training session. Your posting orders will be issued after their successful completion of the training and according to their performance in training.


