**Subject: State Subordinate Accounts Services (SAS)-Part II (OB/LAD) Examination.**


I am directed to invite a reference to the subject noted above and to inform that next S.A.S Part II (OB/LAD) Examination is likely to be held in 1<sup>st</sup> week of August, 2019. The exact date of Part II (OB/LAD) Examination and place will be notified by HIPA Gurugram in due course. Application of eligible candidates to appear in the State S.A.S Part II (OB/LAD) Examination, duly forwarded by Head of Department should be uploaded on the SARAL web site in all respects by 15.7.2019(5:00 PM). Application received after this date will not be considered.

2. The fee for the examination is Rs. 3000/- (Rupees Three Thousand only). The same should be remitted by the candidates while submitting forms online through any one of the payment mode available in E-GRAS. No application will be entertained without requisite fee.

3. The following instructions should be kept in view while forwarding the application:-

- (a) The application should be complete in all respects; incomplete applications will not be entertained.
- (b) All particulars entered in the application should be duly certified by the Head of office/Department as per service book of the candidate.
- (c) The name of the candidates should be recommended for the examination after complete verification of the service record of the officials to ensure that their integrity is above board. Certificate in this regard duly signed by HOO/HOD will be uploaded by the candidate while filling the form online on SARAL web portal. The summary of last ten years ACRs (duly attested) may please also be sent.
- (d) The candidates may also be informed that withdrawal from the examination will not be accepted except in rare cases on medical certificate of illness from the Civil Surgeon concerned.
- (e) Candidates who have qualified SAS Part-I exam are only eligible for appearing in SAS Part-II exam.
- (f) The requisite document/certificates of the candidates will be verified after qualifying the SAS Part-II exam. If any facts of a candidate are found incorrect at any stage his/her candidature shall stand disqualified automatically.

4. All the Heads of Departments are requested to direct their subordinate offices to circulate this notice to all eligible candidates and ensure that the applications for S.A.S Part II (OB/LAD) Examination should be uploaded by 15.7.2019(5PM).
