Subject: - Instructions regarding request for re-appropriation of funds and submission of bills in Treasury in month of March, 2019.


In continuation of the instructions issued vide No. 28/14/2011-5 dated 05 December, 2012, 16th January 2013, 10 January, 2014, 24th March 2015, 09th February 2016, 22nd March 2016, 22nd February 2017 and 01 March 2018. The Government has decided further to improve upon the procedure and to reduce unproductive expenditure/curb parking of funds as follows:-

No bills including Works Bill, except Salary, Wages, Discretionary Grants, Petty Grants, Medical Reimbursement GPF Advance & Withdrawal under Centrally Sponsored Scheme will be passed by Treasury after 15.03.2019.




